

## 2015 YOUTH FIREARM DEER HUNT APPLICATION

U.S. Army Corps of Engineers

Lake Shelbyville

### GENERAL INFORMATION

1. On October 10 and 11, 2015, the U.S. Army Corps of Engineers will host a controlled, youth firearm deer hunt on the Lake Shelbyville Project in Shelby and Moultrie Counties. To be considered, each applicant must be less than 16 years old on October 10, 2015. In addition, the youth must be accompanied (at all times) by an adult of at least 18 years of age. The youth OR their helper must possess an Illinois Firearms Owner Identification (FOID) card and have it with them while hunting IF they are an Illinois resident. Non-residents do not have this requirement.
2. Each successful applicant must also purchase a 2015 youth either sex deer permit which can be purchased for \$10.50 at any over-the-counter licensed vendor starting in September. Youths should NOT purchase their permit until they know if they are drawn and what county they are assigned.
3. Applications for the drawing must be received in the Lake Shelbyville Project Office no later than **4:00 p.m. on September 16, 2015**. A public drawing for permits will be held on **September 17 at 8:00 a.m.**, at the Lake Shelbyville Project Office. Shelby or Moultrie County will be assigned according to your top pick on your application. If you are willing to accept either county, check your first choice AND "Will accept either county". If your first pick is not available you will be placed in the other county.
4. To be eligible for the permit drawing, you must submit the official 2015 Youth Firearm Deer Hunting application form below.
5. All requested information must be provided on the application form. Incomplete or incorrect applications will not be entered in the drawing. Once your application has been submitted, changes will not be made.
6. Successful applicants will be notified by phone within the day of the drawing date. Permits are non-transferable, and individuals may not submit more than one application.
