- **B. Typical year assessment(s):** The site delineation was completed on May 23, 2021 which is seasonally within the wet season in the region. Rainfall totals at the time were slightly dryer than normal, but being during the wet season, these rainfall quantities were at or above normal rainfall quantities in the majority of a typical year. Therefore the Corps believes that the site observation presented in the site delineation provide adequate information to justify conditions in a typical year for flow assessments.
