**PURPOSE AND PROPOSED DESCRIPTION:** Umbrella Mitigation Banking Programs are one of several practicable options available to applicants to compensate for unavoidable impacts to waters of the United States that are associated with permits issued under the authority of Sections 404 and 401 of the Clean Water Act and Section 10 of the Rivers and Harbors Act of 1899. The original instrument for Illinois and Missouri outlines the circumstances and way the program provides compensatory mitigation options to permit applicants under the Corps of Engineer's permit program.

WFI-Holdings-B LLC (program sponsor) has notified the U.S. Army Corps of Engineers of a change with their business entity. The entity of WFI Holdings-B, LLC has changed its legal name to **Naturion West, LLC**. All ownership and entity officers and directors have remained the same.
