


Figure 1: Vicinity of Project Area Map

Location

Project authority covers communities in Madison and St. Clair Counties, Illinois (IL).

Description

Project purpose is to provide water and wastewater assistance including stormwater assistance within Madison and St. Clair Counties, IL.

Status

Water Resources Development Act (WRDA) 2024 included authorized increase in Federal funding limit from \$100M to \$150M and added stormwater management assistance There are three active construction projects covered under this authority. Projects located in Wood River and Belleville IL are installing new infrastructure to separate the currently combined sewer systems. A project located in Cahokia Heights is utilizing Cast in Place Pipe technology to line the existing main trunkline of the system.

Importance

Operating, managing, and keeping sewers functional as well as reducing overflows is necessary for continued economic development and overall health and safety of the public.

Authority

Section 219(f)(55) of WRDA 1992, as amended by Section 108(d)(55) of Consolidated Appropriations Act 2001, Section 352(b)(3) of WRDA 2020, Section 8375(b)(2)(K) of WRDA 2022, and Section 1304(b)(1)(T) of WRDA 2024

- Belleville Phase 3 Award Late FY2025
- Cahokia Heights Sewer Mapping Contract Award Late FY 2025

Activities for FY25

\$7.91M was received through the DRSAA of 2025. These funds will be used to complete a new Letter Report for Cahokia Heights Sewer Mapping project. Complete a Letter Report and execute Project Partnership Agreement (PPA) with new sponsor, the City East St. Louis. Complete a Letter Report for Phase 3 of Belleville Sewer Separation project. Each of these actions will be followed by the necessary contract and construction activities.

Activities after FY25

\$20,325,000 could be used towards construction of additional phases of the Wood River Sewer Separation project, the Cahokia Heights Trunkline project, and the East Interceptor system in Cahokia Heights.
