To help in your review of the July version of the FS-EIS, which is a large document, revision bars have been placed in the text margin to show were text was changed from the February version. These revision bars will be removed in the next revision.

DOE's intent is to keep the Proposed Plan at a level friendly to the lay person. Revisions to the Proposed Plan reflective of your comments were made with this intent in mind. Thus the technical detail provided in the FS-EIS and Response to Comments was not carried forward to the Proposed Plan.

In your May 19 letter you mentioned pending comments from legal council. Would you please advise me of the status of this review. I look forward to working with you in keeping our joint on-schedule progress apace on the St. Louis Site remediation project.
