### MINUTES LOCAL PRIORITIES WORKING GROUP

### May 17, 1995

The meeting was called to order at 9:45 a.m. by James Dwyer. Those in attendance were:

SLAPS PROPOSAL. After considerable discussion regarding the \$500,000 proposed project, the following motion was passed:

The Priorities Working Group requests that the Task Force ask the DOE to reconsider and temporarily delay its decision to add dirt and crushed stone on the northernmost 4% of the Airport Site in light of such concerns as public utility repairs, drainage, and a potentially incorrect public perception that remediation is under way.

Motion carried with five (5) YES votes, one (1) NO vote, and one (1) ABSTENTION.

Ms. Price reported her impression from the National Stakeholders Conference that funding is a major challenge, and stated she was left with the impression, "You have to fight long and hard for what you want" by effective lobbying of Congress.

ST. LOUIS AIRPORT SITE - STABILIZATION NEASURES

As requested by your staff, I am transmitting summary information on a stabilization measure proposed for the St Louis Airport site. While I do not believe these measures are necessary to address any imminent health risks, they will serve to reduce the elevated exposure potential posed by a publicly accessible portion of the site. Both Environmental Protection Agency and Missouri Department of Natural Resources representatives have expressed concerns over this portion of the site. In fact, our current proposal to cover this area with clean soil is primarily a response to concerns expressed by your agency and the EPA.

Several points need to be understood regarding this proposal. These include;

- the cover is not intended as a permanent remedy for the underlying soils;
- implementing the proposal will not constrain future long-term alternatives for managing the underlying soils;
- a liner will be placed between the contaminated soil and the imported clean soil;
- if the contaminated soil is ultimately excavated, the imported clean soil can be used as backfill, and as such, would not be "wasted";
- City of St. Louis and Airport authority officials support the proposal; and
- other options for eliminating the exposure hazard presented by this area would cost much more than is available in the current year budget.

Some members of the St. Louis Site Citizens Task Force have questioned the need for this activity. Questions have centered primarily on whether or not current conditions require any near-term response, and whether this activity should be a budget priority given current funding limitations.

#### Hr. David A. Shorr

If MDNR doesn't support this proposal, I will not proceed with implementation. Since we are nearing completion of other field activities at the airport site, a quick decision to proceed would avoid the cost inefficiencies associated with demobilization/remobilization under a lengthier decision process. We do have the option of cancelling the project and quickly redirecting these FY 95 funds to other projects in the area.

Dear Mr. Adler:

This letter is in reference to your request for an emergency action at the St. Louis Airport Site (SLAPS) to control erosion and to essentially cover "hot spots" that are presently exposed.

As you are aware, the state of Missouri has had considerable concerns regarding previous proposals for installation of a containment facility at the SLAPS site. It is our understanding that this is a <u>temporary</u> measure in an effort to stabilize the site and is not part of an on-going planning strategy for final resolution of the site. This is to remind you that the state of Missouri objects to the previous proposals to provide for an unlined site in contact with groundwater at the St. Louis Airport.

With regard to a temporary action to contain "hot spots," the state of Missouri is <u>supportive</u> of this action to provide cover over locations within the perimeter. Our understanding is that the conditions relating to this concurrence are as stated in your letter received May 11, 1995.

In addition, I am reminding you of the state of Missouri's definitive position of the requirement that you <u>must</u> receive a stormwater permit for this site. While we do not believe that a stormwater permit is absolutely necessary for this interim action, a final stormwater permit for this site is still required. We eagerly await your application. Mr. David Adler Page Two

In conclusion, you have the support of the state of Missouri to take your interim action provided it is not a final remedy at this location.
