As was agreed during the Task Force meeting earlier this week, there will be a special meeting held this coming **Tuesday**, **June 25**, beginning at 5 p.m. at the Hazelwood Civic Center East, 8969 Dunn Road, Hazelwood, Missouri, 63042. A proposed agenda is enclosed.

Subsequent meetings will provide a forum for discussion of all relevant issues and for consideration of how adoption of the preferred remediation plans would serve to meet the needs of the St. Louis community as a whole.

I urge you to come to this meeting prepared to present your interests and goals, and to listen carefully as others explain theirs.

The Priorities Working Group has been very active over the past month and, while it has not yet developed its final report and recommendations to present to the Task Force, it has reached several important milestones which are summarized below for your review and consideration. Please note: Because these actions were finalized just this past Wednesday, May 15, this report is being distributed prior to review by the working group. This is a draft document and is subject to modification. However, it was agreed that the information should be presented to the Task Force quickly, in order to allow an opportunity for informed discussion of these matters at the Task Force meeting on May 21.

- 1. The working group has concluded that it is not possible to resolve several important issues related to the ballfields cleanup proposal in time for the funds allocated to that project to be expended in FY 96. The unresolved issues include matters such as liability, cleanup standards and the priorities of the City of Berkeley. Accordingly, the working group recommends that DOE be advised not to proceed with the EE/CA process for the ballfields at this time.
- 2. The working group has discussed several options for the reallocation of those funds in FY 96. They are:
 - Expand current North County haul route cleanup project.
 - Implement interim remedial action measures at SLAPS to address stormwater management and erosion control concerns, as suggested in the Coldwater Creek Panel report.
 - Develop and implement remedial action measures at the floodwater control levee east of the Downtown Mallinckrodt Plant, in order to allow completion of that segment of the Riverfront Trail.

Additional information concerning these proposals has been requested from DOE, following receipt of which the working group will continue its discussion and develop its report and recommendations.

3. The working group has identified proposed overall cleanup priorities and has ranked them using a point system. Additional details can be found in the minutes of the May 15 meeting of the working group, which will be distributed to all Task Force participants once they have been approved.

Several components of the site were combined for purposes of developing these priorities. They are listed below in order of priority, with the vote tally indicated after each site component:

- SLAPS/ballfields -- 37
- SLDS/Riverfront Trail/SLDS Vicinity Properties -- 27
- North County haul routes/Latty Avenue Vicinity Properties -- 27
- Futura/HISS -- 24
- Coldwater Creek -- 13
- West Lake Landfill -- 7
