RE: INITIAL FIVE-YEAR REVIEW REPORT, for the FORMERLY UTILIZED SITES REMEDIAL ACTION PROGRAM (FUSRAP) ST. LOUIS FUSRAP SITES - Public Review Draft

Dear Ms. Cotner:

The Missouri Department of Natural Resources has completed its review of the above referenced document. We commend the U.S. Army Corps of Engineers (USACE) on the quality of this document, and believe it describes the activities of the last 5 years in a manner that is easily understandable. In addition, we believe your staff did an excellent job of trying to follow available guidance, obtain public opinion, and involve regulatory agencies with the preparation and review of this document.

Please note that the department currently continues to disagree with two statements made in the Five-Year Review document concerning groundwater. The first, on page VI-17, first paragraph, is a statement regarding whether contamination could migrate to lower aquifers. And, secondly, on page VI-17, the last sentence of the third paragraph, is a statement regarding an increasing arsenic trend in one well at the SLAPS, and how it cannot be related to FUSRAP-related activities at the SLAPS.

The USACE should, at a minimum, note that: 1) radionuclides and arsenic are detected in the surrogate intervals for monitoring the lower aquifer; 2) and that previous USACE documents had speculated whether these detects were indications that migration was occurring. Arsenic levels continue to exceed the MCLs and radionuclides are at levels exceeding previous USACE developed values associated with ambient conditions. Further details regarding the USACE's

change in their position on each of these issues, or if the arsenic and radionuclides present are naturally occurring or from other sources, should be provided.
