Dear Mr. Wall:

Pursuant to Section XXI of the Federal Facility Agreement, the U.S. Army Corps of Engineers (USACE) respectfully requests an extension of 120 calendar days for the 90-day timetable and deadline established in Section IX.C. of the FFA, dated June 26, 1990, for submittal of the proposed Record of Decision (ROD) for the North County Site. USACE believes good cause exists for this extension due to the large number and complexity of the regulatory and public comments received on the North County Site Feasibility Study and Proposed Plan. Although fundamental changes to the preferred remedy are not anticipated, some technical reevaluation will need to be performed. Addressing these comments and incorporating them, as applicable, into the draft ROD and Responsiveness Summary will require a significant level of effort. Once the applicable comments have been incorporated the draft ROD will undergo an internal USACE review prior to being released for regulator review. As shown in the enclosed proposed schedule for the North County ROD, the 120-calendar day extension would result in the submittal of the Regulatory Review Draft North County ROD on February 4, 2004. We respectfully request your written concurrence of the 120-calendar day extension and the enclosed schedule.

Copies of the regulatory and public comments received on the North County Site Feasibility Study and Proposed Plan will be sent under separate correspondence. A copy of this letter, including the enclosure, is being sent to Mr. Robert Geller and Mr. Eric Gilstrap of the Missouri Department of Natural Resources.
