DOE Stewardship Meeting

As has been discussed at our recent meetings, the Department Of Energy will ultimately assume responsibility for long range stewardship of the St. Louis FUSRAP sites when remediation is finally completed. While such action may still be several years away, DOE staff from Grand Junction, Colorado, who will ultimately draft the Stewardship Plan, are interested in at least familiarizing themselves with the St. Louis FUSRAP sites.

Therefore, the Committee and USACE project staff will meet with DOE representatives on Thursday, January 27, at 1:30 pm, at the Latty Ave. trailers. This is not really a formal meeting, per se.
