Re: Request for Extension of Comment Period -- "Derivation of Site Specific DCGLs for North County Structures" (June 25, 2004)

Dear Ms. Cotner:

On behalf of the General Investment Funds Real Estate Holding Company ("GIFREHC"), we request a 45-day extension of the public comment period (through September 20, 2004) respecting the document, "Derivation of Site Specific [Derived Concentration Guideline Levels]" (June 25, 2004) (the "DCGI's"), as announced in the Corps' July 6, 2004 notice of availability mailed to stakeholders. As you know, GIFREHC's subsidiary owns Vicinity Property 2L, located immediately adjacent to the Hazelwood Interim Storage Site ("HISS"). The Corps has reported that "elevated levels" of radiological contaminants were detected on certain exterior components of structures on that property. See CEMVS-PM-R, "Memorandum of Record: Rationale of Building/Structural Cleanup and the Derivation of DCGLs at the North St. Louis County Sites" (Jul. 7, 2004). For these reasons, GIFREHC may be directly and significantly impacted by whatever guidelines are selected at the close of the comment period, and GIFREHC intends to review the DCGLs and provide its comments to the Corps.

Although the notice of availability to stakeholders is dated July 6, 2004, GIFREHC did not receive the notice of availability until yesterday (July 19). The postmark on the envelope indicates that it was not mailed until July 14 at the earliest (copy attached). Given the highly technical and voluminous record associated with this action, the effective 18-day public comment period allowed by the Corp is insufficient to allow GIFREHC and others to retain the necessary outside expertise to develop and submit meaningful public comment. Moreover, in view of the 26 years of study already devoted to this effort by the Government, forestalling a final decision for another 45 days would represent only an insignificant postponement, would not prejudice human health or the environment, and would result in more meaningful public input on these important but highly technical matters.

In light of (i) the potential impact and importance of the Corps' decisions on GIFREHC and other Vicinity Property owners in particular, and on the North County community generally; (ii) the practical impossibility of providing meaningful review and comment within the currently allotted time; (iii) the absence of any meaningful opportunity for judicial review after the

decisions are made; and (iv) the negligible deferment involved; we respectfully request, on behalf of GIFREHC, that the Corps extend the comment period by 45 days to and through September 20, 2004.
