Formerly Utilized Sites Remedial Action Program

SUBJECT: Public Review and Comment Period for the "North County Site Feasibility Study and Proposed Plan"

Dear Concerned Citizen:

The Formerly Utilized Sites Remedial Action Program (FUSRAP), administered by the U.S. Army Corps of Engineers (USACE), St. Louis District, conducted site characterizations at the St. Louis North County Site. The FUSRAP program addresses contamination generated by activities of the Manhattan Engineer District / Atomic Energy Commission (MED / AEC) in support of our nation's early atomic energy program. Analysis of samples of the site's soil and sediments has confirmed the presence of MED / AEC contamination in the forms of radium, thorium, uranium, and their decay products. The North County Site includes St. Louis Airport Site (SLAPS), the SLAPS Vicinity Properties (VPs) and the Hazelwood Interim Storage Site (HISS) / Latty Avenue VPs.

The USACE has been working to develop cleanup alternatives for the North County Site. In accordance with the Comprehensive Environmental Response, Compensation, and Liability Act, these alternatives are presented in two documents: the St. Louis North County Site Feasibility Study and the St. Louis North County Site Proposed Plan dated May 1, 2003. Both documents are now available for public review and may be viewed at the locations identified in the enclosed Public Notice, which will be published April 30, 2003 in the St. Louis County Journals and May 1, 2003 in the St. Louis Post Dispatch.

Comments provided as a result of public and regulatory agency review will help select the final remedy for the North County Site. After a final remedy has been selected, engineering plans, work instructions, health and safety plans, and an environmental compliance plan will be prepared, as necessary.

The Feasibility Study identifies and evaluates six alternatives for cleaning up the St. Louis North County Site. The Proposed Plan identifies the USACE-preferred alternative for the North County Site, provides the rationale for this preference, and includes summaries of the five other cleanup alternatives evaluated.

The USACE-preferred alternative is Alternative 5, "Excavation with Institutional Controls under Roads, Bridges, Railroads, and Other Permanent Structures". However, the final remedy will not be selected until USACE has received and considered

all public and regulatory agency comments obtained during the 30-day comment period. The 30-day comment period begins on May 1, 2003 and ends May 31, 2003.

Interested parties are encouraged to submit written or oral comments. Availability of the St. Louis North County Site Feasibility Study and Proposed Plan (FS/PP) for Public Review and Comment

Contamination is the result of activities associated with the nation's early atomic program. It is being addressed under the Formerly Utilized Sites Remedial Action Program (FUSRAP). The North County FS/PP presents cleanup alternatives for the following sites: St. Louis Airport Site (SLAPS), SLAPS Vicinity Properties (VPs), and Hazelwood Interim Storage Site (HISS)/Latty Avenue VPs. While the FS describes the six alternatives in detail, the PP identifies the alternative recommended by the Corps, Alternative 5. Alternatives include:

- 1. No Action Leave the site as is with periodic environmental monitoring.
- 2. Partial Excavation and Capping at SLAPS and HISS Excavate soil from the VPs and dispose out-of-state. Cap SLAPS and HISS and use institutional controls to limit access to contaminated areas.
- Partial Excavation and Troatment Excavate impacted soils from the VPs and HISS, then consolidate and treat at SLAPS.
 Use institutional controls to limit access to contaminated areas.
- Institutional Controls Use institutional controls such as deed notices, land use restrictions, and zoning restrictions to limit future land use at SLAPS, HISS and the VPs.
- Excavation with Institutional Controls Under Roads, Bridges, Railroads, and Other permanent Structures Excavate
 impacted soils from SLAPS, HISS and the VPs. Place institutional controls roads, bridges, railroads and other permanent
 structures.
- Excavation at all Properties. Excavate impacted soils from all locations, regardless of accessibility, for out-of-state disposal.
