To all Federal employees: President Bush has signed an Executive Order that designates this Friday, 11 June, as a National Day of Mourning - to be treated as a Federal holiday for pay and leave purposes. Government facilities that can be closed will be closed and Federal employees given the day off as with other holidays. Employees assigned to facilities that may not close, who cannot be released from duty, will receive holiday pay if Friday is a regularly scheduled workday. Employees whose work schedules do not include Friday should be given an "in lieu of" holiday on the workday immediately preceding Friday. Part time employees whose work schedules do not include Friday do not receive an "in lieu of" holiday day off. Employees previously scheduled to take leave on Friday will not be charged with leave on that day.
