The next meeting of the St. Louis FUSRAP Oversight Committee will be held on Friday, December 14, 2001, 11:30 am, at the trailers on Latty Ave.

Committee members who cannot attend should contact the chairperson at the above numbers to be excused.

This will be a very important meeting. I urge all members, including those of you who have not been able to attend recently, to be present. There are significant concerns being raised about both the clean up standards being proposed in the North County ROD and the Long Term Stewardship Plans for the St. Louis site in general that need immediate attention. It now seems obvious that, despite information provided by DOE to the Task Force and the Oversight Committee, most of the St. Louis FUSRAP sites will require some form of Long Term Stewardship. Clean up, even to the 5/15/50 standards endorsed by the Task Force, will not allow the sites to be fit for unrestricted use. Potentially, this has significant implications for local and county governments as well as utilities, land owners, etc.

Following the usual USACE staff report on the progress of the clean up at this meeting, the Committee will continue discussions about the issues identified at last weeks informational meeting (see attached issues list). The Committee will also have the opportunity to speak with Dan Wall of EPA via conference call to ask questions relative to Records of Decision (past and future).

I hope to see you next Friday.

#### Summary of November 9, 2001 Meeting

Committee Members Present: Ric Cavanagh, Sally Price, Tom Binz, Jan Titus

Committee Members Excused: Tom Manning, Jim Grant, Bill Brandes

Other Interested Parties: Jack Frauenhoffer, Larry Erickson, Eric Gilstrap, Jill Groboski, JoAnne Wade, Dave Wagoner.

The following information is in addition to the handouts provided by USACE at the meeting (see attached).

- Page 4 The bench test for water treatment failed, believe it was the result of algae contamination. Will try again after Thanksgiving.
- Page 5 HISS piles are gone, cleaned only to the ground (not sub surface soil). GIFREHC work is slow because of asbestos in flashing. VP 24 is along Pershall Rd, Frost Ave. (want to build a structure there, in Berkeley).
- Page 6 Sharon Cotner stated that the project is getting close to running out of work under the EE/CA (perhaps by spring of 2003). If funding remains fairly constant, work at North County will be done somewhere in the 2007 10 time frame.
- Page 7 A high level hit of Uranium led to the remedial investigation. DT-10, won't remediate, still waiting for guidance from HQ. DT-12, stalemate: Railroad wants a hold harmless clause which the government will not grant. USACE needs another Right of Entry agreement for Midwest Waste (renewal).
- Page 8 Buffalo will run out of money by January; they are putting pressure on their congressional delegation. We could use \$10 million more. We will need to get support from our congressional delegation. DOE staffer Chris Clayton visited St. Louis but didn't stay for the St. Louis Long Term Stewardship meeting.
- Page 11 Committee can get final AAA report under the Freedom of Information Act.



# Progress Report St. Louis Airport Site (SLAPS)



Gateway to Excellence

- Remedial Design
  - Pre Design Investigation for Phases 4 / 5/6 Published 31 OCT
  - Design Basis Memorandum for Phases 4 / 5 / 6 (IA1 / 6) Due 26 NOV
  - Work Description for Phases 4 / 5 60% due in FEB
    - Site Wide Grading Plan Received approval from Airport Authority Published REV 0.
- Removal Actions
  - East End Excavation ongoing in the East End
    - · The contractor is currently excavating at SU10 and and shipping stockpiled soils.
      - SU 11, 12 and 13 are currently being backfilled.
      - Two SU's, adjacent to the Radium Pits, will remain and be addressed in Phase 1 (IA5) next summer
    - 65,000 cyds expected, 50,808 cyds shipped to date, 10,000 cyds stockpiled
  - Status of water treatment system Bench test effective for U, not for Se
    - System is being modified / equipment being changed to ensure it meets contractual specifications - next test early DEC
      - High organic content is suspected of fouling the filter on the first test.
  - Rail Shipments off SLAPS

# Progress Report Hazelwood Interim Storage Site (HISS)/Latty Avenue

    - Contractor has completed removal of the pile and is currently decontaminating equipment and demobilizing.
      - Expected to be offsite prior to Thanksgiving
    - 7,338 cyds were shipped
  - GIFREHC Roof Replacement
    - MVS is supporting a GIFREHC roofing contractor by conducting radiological support, transportation and disposal associated with the roof removal.
    - Replacement work began 15 OCT. Expect to work 22 days for Phase I, Phase II will be in the spring and is expected to take 41 working days.
    - 4,000 cyds are expected. 300 removed to date
  - Rail Shipments off HISS
    - 3001 cyds shipped to date / 5,000 cyds planned


