





## Progress Report St. Louis Downtown Site (SLDS)



Gateway to Excellence

#### Pre-Design Investigation (PDI) -

- South Angelrodt VPs Walkovers are complete. Sampling plans to be developed based on historical assessments. (Gunther North, Cotto Waxo, Starr Bedding, Christiana Court pending)
- West Broadway VPs. Historical interviews and walkovers complete. Sampling complete except for one property.
- Thomas & Proetz VP Additional samples incorporated into the PDI report. Report to be issued end of April.
- MI Plant 6W (South Bldg 101) Draft PDIR issued for review and comment.
  - Plant 6W (West Bldg 101) Additional PDI sampling underway. Initial samples complete. Contingency samples being collected.
  - Plant 7 N/S PDI report under internal review.

#### Remedial Design -

- MI Plant 6W (S of Bldg 101) Incorporating comments from internal review. Design
  to be issued in May. Need letter of accessibility from MI. Plant 6W (West Bldg 101) —
  Design in initial stage of dev. Plant 7 N/S Design in initial stages of dev.

#### Remedial Action

#### Mallinckrodt

- Plant 1 3,724 cyds remediated Post Remediai Action Report (PRAR) USACE review complete. Internal comments being incorporated. Regulator review by later this month.
- Plant 6E / 6E1/2 22,958 cyds remediated The RAS complete and the contractor is working on the PRAR.
- Mi Plant 7E Completed in SEP 03. 1,319 cy excavated. PRAR for internal review to be delivered by end of April.

#### · VP's

- Midwest Waste/Heintz Steel Completed SEP 01 & SEP 03, respectively. (MWW 4,775 cy; Heintz 1,663cy) RAS & PRAR for properties has been combined. Responses to internal comments on the RAS are working. PRAR is next.
- McKinley Bridge RA complete JAN 04. Approximately 2,800 cy excavated. Restoration (except bike path) is complete. Final restoration of the bike path awaiting warmer weather. RAS for internal review expected by end of April.

- MSD support in FY04 Sewer line project along Eva and Frost next FY

### **Progress Report** St. Louis Airport Site (SLAPS)



- Designs Complete for SLAPS
- **Removal Actions** 
  - Phase 2/3 excavation Continues. 75,000 cyds expected
    - Approximately 76,500 cyds have been excavated to date
    - This Phase consists of 10 Survey Units 6 complete to date. Backfilling SU33. Currently working SU34 next to McDonnell Boulevard.
  - Phase 4/5 (CWC removal action/restoration)
    - · Approximately 1,500 cyds have been excavated to date.
    - CWC removal action/restoration on hold until August. AmerenUE to complete GKN power supply relocation by end of June.
    - . SU38 (adjacent to McDonnell Blvd.) partially excavated for sheet-pile tie back installation.
  - Phase 6 excavation
    - · Approximately 8,000 cy removed.
  - Water storage/treatment
    - · Water storage basin located in SU-34/35; sedimentation basin relocated to SU47.
    - · Water treatment to begin in May.
- Rail Shipments off SLAPS
  - 48,600 cyds shipped to date / 85,000 planned.



### **North County ROD Status**



Gateway to Excellence

- The North County Record of Decision
  - Draft ROD and Responsiveness Summary is currently under Regulator review.
    - ROD issued 10 Feb.
    - · Meeting held in Jefferson City
    - USACE agreed to a 20 day extension of the review period. Comments now due May 3.
  - Derivation of Site-Specific DCGLs for North County Structures
    - Comments were due 1 DEC from the USEPA and MDNR
      - MDNR requested an extension to 15 DEC for their comments and 31 DEC for MDOH comments.
      - USACE met with EPA & MDNR to resolve comments.
  - GW Technical Working Group Meeting
    - Meeting with EPA and MDNR (FFS & DGLS) held 25 Mar 04.
    - Group discussed site cleanup actions to date, provide an update on the SLDS Groundwater Remedial Action Alternatives Assessment (GRAAA) and explain groundwater monitoring as it is presented in the Draft North County ROD.
    - · Next meeting 27 APR 04

## Derived Concentration Guideline Levels (DCGLs) for Structures



- Derived pursuant to 10 CFR 40, Appendix A, Criterion 6(6) for structures
- Limited number of structures are located in proximity to contaminated soils and thus to be impacted
- Impacted structures will be subjected to final status surveys

## "Surface and Volume Radioactivity Standards for Clearence" (ANSI-N13.12-1999)



Gateway to Excellence

- Provides clearance criteria derived for release of materials and equipment from controlled areas
- Criteria developed to replace those specified in NRC Regulatory Guide 1.86
- Surface contamination "Screening levels for clearance" are <u>600</u> and <u>6000</u> dpm per 100 square centimeters for thorium-230 and uranium-238, respectively.
- Criteria based on 1 mrem per year

## Development of Derived Concentration Guideline Levels (DCGLs) for Structures



Gateway to Excellence

- Use the ARAR-based residential benchmark dose (19 mrem/yr) constrained to 15 mrem/yr per EPA guidance
- Input parameter inputs EPA>NRC>ANSI>RESRAD Build defaults
- DCGLs are 6,900, 15,000 and 19,000 dpm/100 cm<sup>2</sup> for Th-230, Ra-226, and U-238 respectively.
- DCGLs applied using Sum of the Ratios.
