**Summary of December 8, 2000 Meeting**

The following comments are in addition to the handouts provided by USACE (see attached).

Page 4 - A letter is being drafted requesting the County Executive's assistance in modifying the existing permit with St. Louis County Highways and Traffic to allow excavation of shoulders along Banshee and McDonnell Blvd. as needed.

Sharon reported that the Corps is getting a clean trailer from Weldon Springs at no cost which will eliminate the need for rented modular units. This will result in significant cost savings.

Page 6 - VP 2c is railroad property and there have been some problems getting cooperation from the railroads in the past.

Page 8 - Further study is being done on VP's to clarify why there seems to be some "gaps" (non contiguous properties) to DOE's definition of the St. Louis FUSRAP site.

Sharon also reported that an Army Audit team will be on site in December and January. They will be addressing decision making regarding PRP's (Potential Responsible Parties), Regulatory input, and proposed clean up standards.

Sharon also indicated that she would be requesting an additional \$4 million for St. Louis plus some other possible funds from other sites for this year's budget.

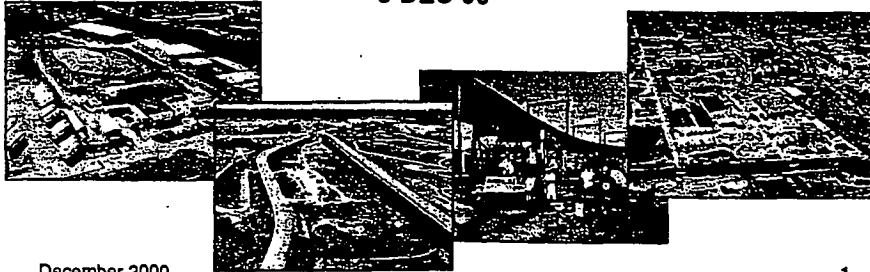

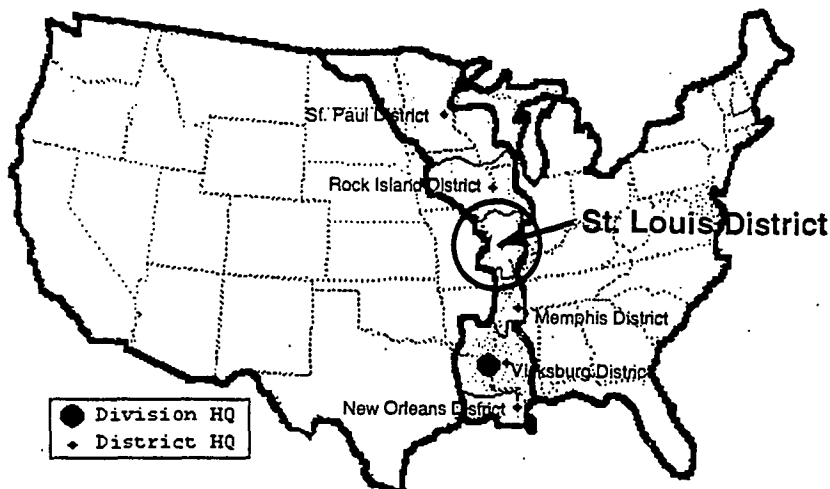

## Progress Report St. Louis Airport Site (SLAPS)



Gateway to Excellence

- **Remedial Design**
  - Preliminary Design Investigation of the site continues.
    - Approximately 81 additional borings are needed to resolve data gaps, verify existing data.
    - Work Description for remediation of Investigative Areas 5 and 6 Design pending start (IA 5 is S of Radium Pits and IA 6 is a smaller area W of the Rail Loading facility) - 60% complete
- **Removal Actions**
  - **Radium Pits - Backfill operations are ongoing for 4 Survey Units - 45% complete**
    - Status of treatment of selenium (Se) in water - options being evaluated
      - Water is currently contained in tanks and in the excavation sump
      - USACE is in the process of requesting the limit for Se from MDNR
      - USACE is talking with MSD reference discharge limits
  - **East End - Excavation ongoing in the Eastern End Right of Way**
    - A portion of SU22 is currently being backfilled.
    - 45,000 cyds expected, 800 cyds excavated to date
    - Approximately 2/3 will go to Envirocare and 1/3 to Envirocare for disposal
  - **Rail Shipments off SLAPS**
    - 5,829 cyds shipped to date / 60,000 planned

## Progress Report Hazelwood Interim Storage Site (HISS)/Latty Avenue



Gateway to Excellence

- **Remedial Design**
  - **Main Pile South Half (12,500 cyds)**
    - Request for Proposal sent to 8aWOB - Response received 21 NOV
    - Negotiations for contract to take place 20 DEC
    - Expect work to begin for South Half (12,500 cyds) in late DEC / mid JAN
    - Soil will be sent to Envirocare.
    - This contract is for removal of 12,500 cyds on the South Half of the pile. A follow on contract will be issued this summer for removal of the remainder of the pile.
- **Remedial Action**
  - **Supplemental Pile Contract (7,500 cyds)**
    - Contract was being modified to begin work on the North Half on the Main Pile (5,000 cyds) - approximately 1,750 cyds removed to date
      - Supplemental Pile soils sent to Envirocare, Main Pile soils sent to Envirocare.
  - **GIFREHC Pad - A draft PRAR is being prepared to document remediated area.**
    - MVS continues to meet with GIFREHC on roof replacement costs
  - **Rail Shipments off HISS**
    - 6,894 cyds shipped to date / 20,000 cyds planned

## Progress Report SLAPS Vicinity Properties

- **Data Evaluation**
  - Data evaluation of DoE VP removal actions are being finalized for 30 properties.
    - 22 - Expect No Further Action
    - 6 - Need Additional Investigation to determine status
    - 2 - Need Additional Investigation and Probable Remedial Action
- **Characterization Surveys**
  - Gaining real estate access to properties to obtain walkover and sampling data for Plans and Specifications in FY01
    - 56/57/58/59/1C/2C (@2,000 cyds)
    - 31/36/37/39/42/44/46/47/48/48A/49 (@ 400 cyds) - Hazelwood Avenue
    - Remainder of VP38
- **Remedial Design**
  - Two to be completed this year by SAIC (Groupings are as listed above)
- **Remedial Action**
  - A draft PRAR is being prepared for areas addressed at VP38.
  - Rail Shipments of VP soils (Shipped from HISS)
    - 0 cyds planned; however, based on funding / utility work, the number could increase

## Progress Report St. Louis Downtown Site (SLDS)



Gateway to Excellence

- **Remedial Design**
  - **Plant 6W Remedial Design is 60% complete** - On hold pending CT strategy
  - **Pre Design Investigation** - Sampling is ongoing at Heintz Steel
  - **Work Description** - Being prepared for the remediation of Midwest Waste (1,000 cyds), the McKinley Bridge shadow (20 cyds) and Gunther Salt (600 cyds).
  - **Plant 7 & Mallinckrodt W Design** - Conducting Pre Design Investigation
- **Remedial Action**
  - **Plant 2 is complete. PRAR is due 15 JAN.**
  - **Plant 1 continues (@ 1,900 cyds) - 1,641 cyds remediated to date**
    - Current completion date (backfilled) is 15 JAN
    - Concurrent small area excavation is ongoing (3 of 11 areas complete & 3 working).
  - **Plant 6E / 6E1/2 (3,500 cyds) began 3 DEC - Phase IV underway**
    - Phase I has 10 separate areas to be remediated
    - Remediation is split into 4 phases by area
      - Phase II has 1 area, Phase III has 6 areas and Phase IV has 1 area to be remediated
  - **Rail Shipments off SLDS**
    - 782 cyds shipped / 7,500 planned
- **MVS working Utility Agreement at SLDS - at utilities for comment**

  - Draft FS/PP sent to regulators on 7 AUG
    - Comments received from USEPA and MDNR on 27 OCT
    - USACE briefed MDNR on Response to Comments 28 NOV.
- **DoE Program POC's Interactions**
  - None during this timeframe. It is apparent that DoE has not reviewed the FS/PP
- **The Army Audit Agency notified us that they are conducting an audit of our FUSRAP sites 11 DEC.**
  - **Topics are aspects of:** Potentially Responsible parties, Environmental Documentation and Community Relations.
    - It is expected that the data gathering phase of the audit will continue until at least the end of APR 01.

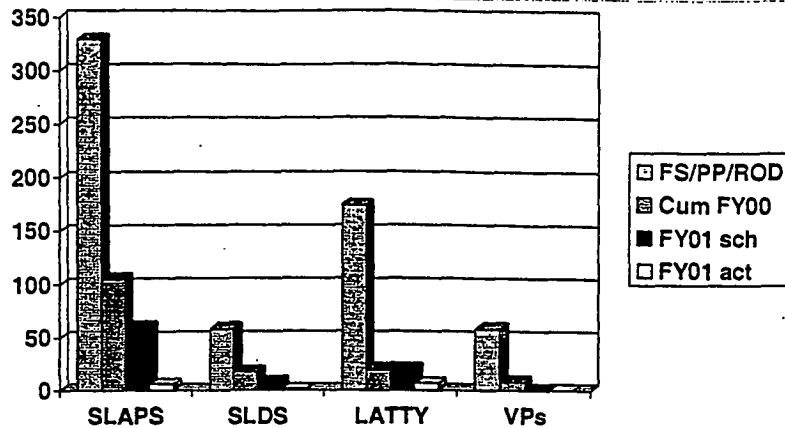
