

Important Budget Considerations!

The Committee needs to discuss proposed FY 2004 budget recommendations for the St. Louis sites. As currently proposed, St. Louis could see a reduction of over \$2 million dollars in FY 2004 (compared to previous years), despite the overall national FUSRAP budget still being pegged at the same \$140 million. It would seem that St. Louis is being "rewarded" for all of its good work by having its budget reduced! No logic here!

I have taken the liberty of contacting the County Executive's office as well as sending letters to the St. Louis area Congressional delegation offices in Washington. D.C. I also have gotten permission to utilize the County's lobbyist, Laura Madden, to help us in this effort. Hopefully, we can get changes in the Corps of Engineers budget that will allow St. Louis project staff to continue to do the good work that has won them awards in the past.

I will share more details at our meeting.

Summary of Meeting January 10, 2003

The following comments are in addition to the handouts provided by the USACE project staff at the meeting.

The Committee welcomed Col. Kevin Williams to its meeting and thanked him for his support.

Page 4 – 34,684 cyds have been removed (not 71). Phase 1 should be done by the end of January. Se issues: Larry Erickson briefed the committee on MDNR review status and issues. Three issues are being reviewed. 1) the status of Coldwater Creek as a metro "no-discharge" creek 2) the effluent rate (more data needed) 3) questions about the Se values submitted (ie. values were based on Western states, these values may be lower in Missouri). In answer to the question as to whether concern is about discharges only in emergency situations or on a daily basis, Larry stressed that this really pertains to post rainstorm situations only.

Page 5 – not much is planned for HISS due to funding limitations

Page 6 – A meeting is scheduled for next week with Thomas and Proetz regarding disruption of owner's business. Remedial Action – rail line will be done last (backing out of the property via the rail line).

Page 7 – The Division is to get the draft ROD in two weeks. March is still the target date for release and public comment. Some recent decisions in New York regarding clean up standards may be in our favor. CRA – we may get an additional \$5.7 million for this quarter. Sharon Cotner announced that Brig. General Donald Riley is the new Division Chief.

Page 9 – A newsletter is due out in February.






