#### Summary of June 13, 2003 Meeting

The following comments are in addition to the information provided by USACE staff at the meeting.

Page 6 – Water is still being treated to meet standards. Treatment of Se will work better in warmer, drier summer weather.

Congress recently authorized an additional \$5 million for FUSRAP. From that amount, \$1 million will be committed to SLAPS (since the priority is to complete projects that are already underway).

Page 7 – The "Legacy Office" will handle Long Term Stewardship for DOE. Its office will still likely be in Grand Junction, Colorado. The Oversight Committee will request a briefing on this reorganization in the fall.

Page 9 – Discussion of Public Hearing. Document with comments won't be available until early 2004. Frequently asked questions will be answered and sent to people who attended.

The Committee discussed the issue of West Lake Landfill. While the site is not currently in FUSRAP, what should the Committee do to get this site on the political agenda? DOE is really a minor player in this issue. Dan Wall of EPA is the point person at this time.

The Committee would like to have the opportunity to meet at a time outside of the regular meeting to wrestle with some of these remaining issues. The Committee Chair will try to contact members by e-mail to make arrangements for such a meeting.





- Groundwater Remedial Action Alternatives Assessment for high levels of U in a well at Plant 6W.
  - · USACE is currently addressing Regulator Review comments
  - Groundwater Technical Working Group meetings to discuss the GRAAA and FS/PP were held on 14 and 29 MAY, respectively.

#### Remedial Design

- Pre Design Investigation Currently ongoing at PSC Metals and Plant 7N/S, Thomas and Proetz report is pending and the McKinley Bridge report is under internal review.
- Plant 7E Work Description REV 0 has been published

#### Remedial Action

- **Plant 1 3,724 cyds remediated -** Post Remedial Action Report internal review comments are being addressed. Next step will be regulator review.
- VP's
  - Midwest Waste (4,800 cyds) RAS (Remedial Action Summary Report) is due in JUL 03. (Will be grouped in a PRAR with Heintz Steel)
  - · Heintz Steel Remediation began in late APR, 3 areas excavated to date 65 cyds removed.
- Plant 6E / 6E1/2 22,958 cyds remediated
  - · RA has been completed for the accessible areas of the Plant.
- MI Plant 7E is next for RA this FY approximately 1,000 cyds are expected.




# Volume Removed Using Environmental Documents
