Summary of Meeting

February 14, 2003

The following comments are in addition to the handouts provided by USACE staff at the meeting.

Page 6 – More work has been done on SLDSS than other sites recently. Mid West Waste is pretty much done, a PRAR will be done soon.

Staff is reviewing priorities for the near future. Due to IDOT's schedules, Venice McKinley Bridge may be next priorities.

Page 7 – The North County ROD issue paper will go to Division next week. It may be reviewed in Vicksburg in the middle of March. This has been an 18 month process thus far.

Discussion of future funding: The good news is that FUSRAP was funded at the national level @\$145 million for FY 2003. There are concerns for FY 2004. For instance, new ROD's would be considered a lower priority. Therefore, North County ROD might get less funding. Also, new sites are being added each year which siphon off funds from existing sites. Finally, there may be varying priorities between the Office of Management and Budget (OMB) and USACE, etc.

Reprogramming: the rule has been changed as of 2/14. There no longer is a \$1 million limit. This is good news.

Sharon announced that Ron Rauh will be filling in for Lou Dell'Orco while Lou is deployed for military duty.
