### REQUEST FOR PERMISSION TO MODIFY A U.S. ARMY CORPS OF ENGINEERS PROJECT UNDER SECTION 408

Interested parties are hereby notified that an application has been received for a Department of the Army Section 408 permission for certain work near federally constructed flood protection projects of the United States, as described below and shown on the attached maps.

REQUESTER: Benton and Associates Inc. Attention: Mr. Bryan Cannon

**LOCATION:** The site is located on and around the Scott County Drainage and Levee District System. The work is located at the approximate coordinates 39°40'28"N 90°37'51"W in Bluffs, IL. (Scott County, Illinois).

**PROPOSED ACTION:** The applicant is requesting to build an additional pump station next to the existing Scott County Pump Station near the Scott County levee embankment. The pumps will take water from the existing intake channel through discharge pipes that will run up and over the levee and discharge into the existing discharge bay. The applicant is also considering a alternate alignment that will reduce the footprint of the project. The alternate alignment is shown in the attached drawing. The project also includes the construction of a bridge across the intake channel, east of the proposed pump station, that will be lined with trash racks to prevent large debris from entering the intakes of the pump stations. The bridge will also provide access for machinery to remove the debris and serve as a path for farm equipment.

**REGULATORY AUTHORITY:** The St. Louis District Regulatory Branch conducted a review of the proposed project and, based upon review of the project activity description, as well as the location of the work, the Regulatory Division determined that project will require the need for a Department of the Army Permit under Section 404 of the Clean Water Act. The project appears to meet the terms and conditions of Nationwide Permit #07 (*Outfall Structures and Associated Intake Structures*). A Section 404 permit will be issued in concurrence with the Section 408 approval.

**EVALUATION:** The decision whether to grant the requested permission for project modification under Section 408 will be based on several factors. That decision will reflect the national concern for both protection and utilization of important resources. The benefit which reasonably may be expected to accrue from the proposal must be balanced against its reasonably foreseeable detriments. Review of the requests for modification will be reviewed by a U.S. Army Corps of Engineers technical review team considering the following factors:

- Impair the Usefulness of the Project Determination. The review team will determine if the
  proposed alteration would limit the ability of the project to function as authorized, or would
  compromise or change any authorized project conditions, purposes, or outputs. The decision
  whether to approve a request for modification would be based on a determination of no
  impairments.
- 2. <u>Injurious to the Public Interest Determination</u>. Proposed alterations will be reviewed to determine the probable impacts, including cumulative impacts, on the public interest. Evaluation of the probable impacts that the proposed alteration to the U.S. Army Corps of Engineers project may have on the public interest requires a careful weighing of all those factors that are relevant in each case. Factors that may be relevant to the public interest depend upon the type of USACE project being altered and may include, but are not limited to, such things as conservation, economic development, historic properties, cultural resources, environmental impacts, water supply, water quality, flood hazards, floodplains, residual risk, induced damages, navigation, shore erosion or accretion, and recreation. The decision whether to approve an alteration will be determined by the consideration of whether benefits are commensurate with risks. If the potential detriments are found to outweigh the potential benefits, then it may be determined that the proposed alteration is injurious to the public interest.
- 3. Environmental Compliance. A decision on a Section 408 request is a federal action and is therefore subject to the National Environmental Policy Act (NEPA) and other environmental compliance requirements. While ensuring compliance is the responsibility of USACE, the requester is providing all information that the St. Louis District identifies as necessary to satisfy all applicable federal laws, executive orders, regulations, policies, and ordinances. NEPA and other analysis completed to comply with the other environmental statutes (e.g. Endangered Species Act) should be commensurate with the scale and potential effects of the activity that would alter the US Army Corps of Engineers project. The scope of analysis for the NEPA and environmental compliance evaluations for the Section 408 review is limited to the area of alteration and those adjacent areas that are directly or indirectly affected by the alteration.

In compliance with Section 7(c) of the Endangered Species Act of 1973, as amended, lists of species and critical habitat were acquired from the USFWS Information for Planning and Conservation (IPaC) website on 1 October 2024 (Project Code: 2023-0131814) for the Proposed Action Area. The IPaC list included the following species: Indiana bat, northern long-eared bat, tricolored bat, monarch butterfly, western regal fritillary, and decurrent false aster. A "may affect not likely to adversely affect" determination was made for Indiana bat, northern long-eared bat, tricolored bat, western regal fritillary, and decurrent false aster. A "not likely to jeopardize the continued existence of" determination was made for monarch butterfly. The proposed action would not impact caves, mines, or artificial roosting structures. The proposed action would not fragment habitat or reduce/convert the area of any habitat. The proposed work would require some minor tree clearing, which would take place between 1 Oct to 31 Mar of any given year to minimize adverse impact to roosting bats. The location of the soil disturbance is within the levee embankment and the roadside areas around the existing infrastructure. The soils would be restored following the excavation. The levee and roadside areas are routinely mowed and maintained to be free of woody vegetation. A population of decurrent false aster, host milkweed for monarch, or violets for western regal fritillary are unlikely to occur in the levee and roadside areas due to routine mowing and maintenance. The pipe will also lead to an outfall on the river, passing through some riparian habitat. The trees that need to be removed are located where the pipe outfall will need to be placed in the river.

An EcoCAT report was generated by the applicant on 16 September 2020 with Report # 2105529. The Illinois DNR provided an evaluation and terminated consultation on 17 September 2020. This consultation expired on 17 September 2022. Illinois DNR was contacted on 13 September 2023 to reinitiate consultation. Illinois DNR responded that same day to say that there were no concerns.

The Migratory Bird Treaty Act (MBTA) of 1918 provides protection for bird species native to North America. The project area is in the Mississippi Flyway, a bird migration route which follows the Mississippi River, the Missouri River, and the Lower Ohio River in the United States. A variety of migratory birds might occur in the project areas, some as migrants and some as breeders, depending on the time of year. Year-round residents would also be present. The construction disturbance could cause temporary minor adverse impacts in the form of noise and vibration from the use of vehicles and equipment.

Although the bald eagle (*Haliaeetus leucocephalus*) was removed from the federal list of threatened and endangered species in 2007, it continues to be protected under the Migratory Bird Treaty Act and the Bald and Golden Eagle Protection Act (BGEPA). The BGEPA prohibits unregulated take of bald eagles, including disturbance. The U.S. Fish and Wildlife Service developed the National Bald Eagle Management Guidelines to provide landowners, land managers, and others with information and recommendations regarding how to minimize potential project impacts to bald eagles, particularly where such impacts may constitute disturbance. USACE has two records for bald eagle nests just north of the footprint for the proposed pump station, but these records were from 2014 and 2015. A survey for nest presence will be completed prior to construction and, if a bald eagle nest is found to be within 660 feet of the action area, then the National Bald Eagle Guidelines shall be implemented.

St. Louis District Archaeologists conducted a Historic Property Preliminary Review on 13 November 2024. Ground disturbance is limited to previously disturbed areas. For this reason,

the USACE – St. Louis has made a "No Potential to Affect Historic Properties" determination.

All actions taken were in accordance with the National Historic Preservation Act of 1966, as amended (NHPA). In the unlikely event that, earthmoving activities associated with the proposed work did impact potentially significant archeological/historic remains, all construction activities and earthmoving actions in the immediate vicinity of the remains would be held in abeyance until the potential significance of the remains could be determined. The precise nature of such investigations would be developed by the St. Louis District in concert with the professional staff of the Illinois SHPO.

- 4. <u>Environmental Impact Statement</u>. A preliminary determination has been made that an environmental impact statement is not required for the proposed work.
- 5. <u>Technical Analysis</u>. The St. Louis District is working closely with the requestor to ensure that all technical plans, maps, drawings, specifications are provided and complete. A District-led Technical Review is being conducted to determine any potential adverse impacts to the US Army Corps of Engineers flood protection system.

<u>SOLICITATION OF COMMENTS</u>: The U.S. Army Corps of Engineers is soliciting comments from the public; Federal, State, and Local agencies and officials; Indian Tribes; and other interested parties in order to consider and evaluate the impacts of the proposed activity. Any comments received will be considered by the U.S. Army Corps of Engineers to determine whether to issue, modify, condition, or deny a permission for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and other public interest factors listed above. Comments are taken into consideration in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity.

<u>SUMMARY</u>: It should be noted that materials submitted as part of the Section 408 request become part of the public record and are thus available to the general public under the procedures of the Freedom of Information Act (FOIA). Individuals may submit a written request to obtain materials under FOIA or make an appointment to view the project file at the St. Louis District Corps of Engineers, Office of Counsel.

Interested parties wishing to comment on the proposed activity must do so in writing no later than **January 9, 2025**. It is presumed that all parties receiving this notice will wish to respond to this public notice; therefore, a lack of response will be interpreted as meaning that there is no objection to the project as described.

This public notice is not a paid advertisement and is for public information only. Issuance of this notice does not imply Corps of Engineers endorsement of the project as described.


