

2021 CONTROLLED DOVE HUNT APPLICATION

GENERAL INFORMATION

1. Hunting in South Sand Creek Dove Field at Lake Shelbyville will be by permit only on September 1st. On September 2nd and throughout the remainder of the 2021 dove season, hunting will be on a first-come, first-served basis.
2. A public drawing will be held to allocate permits for South Sand Creek Dove Field on August 16, 2021 at 9 a.m. at the Lake Shelbyville Project Office. Applications for the drawing must be received in the Lake Shelbyville Project Office no later than 8:00 a.m. on August 16th.
3. To be eligible for the permit drawing, you must submit the official 2021 Dove Hunting Permit application form below. All successful applicants will only be allowed to hunt once, either the A.M. or P.M. slot, not both. Additionally, all **YOUTH** hunters, 18 years old and under, will have drawing preference.
4. All requested information must be provided on the application form. Incomplete or incorrect applications will be returned. Once your application has been submitted, changes will not be made.
5. A \$30 permit issuance fee will be assessed per blind (good for two hunters), payable at the time of application. Successful and unsuccessful applicants will be notified by phone no later than August 17th. Checks or money orders submitted by those who are not successful in the drawing will be refunded as soon as possible after the drawing date. A \$30 check or money order must accompany each permit application. Checks must include name, address, Driver's License number, and telephone number. Permits are non-transferable and individuals may not submit more than one application.
6. A public drawing will take place at 6:30 A.M. for blinds on the morning of September 1st at Whitley Creek Dove Field. Participants should plan on arriving at the field by 6:15 A.M. to enter the drawing.
