

TRAILS

Wappapello Lake offers unique trails to explore our beautiful resources. A brochure is available for the National Recreation Trails of Wappapello to include:



PINE RIDGE NATURE TRAIL

(3/4 mile, Double Loop) Accessible from the Fish Cleaning Station Parking Lot or Redman Creek East Campground

LOST CREEK NATURE TRAIL

(1 mile with 1/2 mile Watchable Wildlife Loop)

Travel 5 miles north of the dam on Hwy D, then left on County Road 523. Follow the signs.

JOHNSON TRACT NATURAL AREA TRAIL (5 miles)

Located 18 miles north of the dam on Hwy D.

GREENVILLE HIKE/BIKE TRAIL (4.8 mile asphalt trail)

Partnership with the City of Greenville. Trailhead is located at the north end of the City of Greenville on Business Hwy 67. Trail runs to the Greenville Campground and Recreation Area and to the Ozark Trail.

MEMORY LANE HISTORIC WALK (1 mile)

Located in the Greenville Recreation Area, explore the Old Greenville National Historic Site.

OZARK TRAIL (33 miles)



The northern part of the Ozark Trail at Wappapello Lake starts just south of Sam A. Baker State Park on State Hwy 143 and runs along the west side of the St. Francis River and Wappapello Lake. Equestrian trailer accesses are at Hwy 172, Hwy 34 (PA 50), Hwy FF (PA 58), Hwy F, Hwy 67 (PA 60) and Corps Roads 27 and 28. Equestrian camping is available at Sam A. Baker State Park, PA 58 and PA 50. Picketing is required at all three locations. Four loop trails are available at PA 60, Hwy 172, Lake Wappapello State Park, and at University Trail.

PEOPLES CREEK MULTI-USE TRAIL (1/2 mile)
1/2 mile from Peoples Creek to Sundowner.

The operation of all terrain vehicles, golf carts and other non-licensed vehicles are prohibited on Corps maintained roadways and within recreation areas.

Off-road vehicles use and operation is prohibited on all Corps of Engineers public lands at Wappapello Lake.

Federal Regulations, including the Archaeological Resources Protection Act (PL96-45), Prohibit the disturbance of archaeological sites on federal lands.

Hunting of feral livestock on lands owned by the St. Louis District (USACE MVS) in Missouri is prohibited.

VISITOR REGULATIONS

Rules and regulations governing public use of U.S. Army Corps of Engineers water resources development projects are published in Title 36, CFR and are posted on bulletin boards or are available from a park ranger. The following additional regulations are in effect for all U.S. Army Corps of Engineers, St. Louis District Projects as authorized in Title 36, CFR 327.12a.

GENERAL

1. The operation of drones or other Unmanned Aircraft Systems (UAS's) is prohibited on all project lands, unless specifically authorized by the Operations Manager.
2. The operation of the powerless flight devices including, but not limited to, sail planes, gliders, balloons, parasails, and hang gliders is permitted. Powerless flight devices shall not be operated on any part of the dam, roads, bridges, or over beaches or other heavy use areas.
3. The use of all kite tubes, defined as a "towable, inflatable device designed to be airborne," are banned from use on Corps managed waters throughout the St. Louis District.
4. All waste water must be collected in a container and disposed of in authorized disposal facilities. In primitive areas where sanitary facilities are not provided, human waste must be buried 100 feet from any body of water and/or campsite.
5. The use of America the Beautiful Senior Pass, America the Beautiful Access Pass, Golden Age Passport, or Golden Access Passport by someone other than the person to whom the pass was issued is prohibited.
6. All motorized vehicles operated on roadways on public land administered by the Corps of Engineers must be licensed and operated by licensed drivers.

PICNIC AREAS

7. Picnic areas, designated by the operations manager and marked with appropriate signs, close at 10 pm. Other areas, which are not posted, will remain open to public use.

BEACH

8. Alcohol is prohibited on the sand and water portions of all swimming beaches and other nearby facilities normally associated with beaches that are marked with appropriate signs. These facilities include but are not limited to picnic areas, parking lots, picnic shelters, etc.

9. All glass and other dangerous objects, including, but not limited to, lawn darts and horse shoes, are prohibited on the sand and water portion of swimming beaches.
10. To avoid unsanitary conditions, all food, pets, and waste materials are prohibited on the sand and water portion of swimming beaches and other posted areas.
11. Beach users must stay within designated swim area.

CAMPING

12. Campers must register and pay fees before setting up on a campsite. Check out time is 4 pm.
13. The maximum number of individuals per site is 8. The total number of camping units for a single capacity site is limited to 1 electric unit and 2 additional tents. If no electric unit is at the site, a maximum of 3 tents will be permitted. Vehicles/equipment will be limited to the amount of designated parking at the site.
14. Campground roads and facilities are to be used by registered campers and their visitors only. Interfering with, or restricting the use of the shoreline by boaters or other lake users is prohibited.
15. All wheeled vehicles, including but not limited to mopeds, boat trailers, motorcycles, and other vehicles, must be kept on camping pads registered to vehicle users or in designated parking areas. All motor vehicles must be parked lengthwise on the camp pad except at sites with irregularly shaped pads. Parking on the grass, roadside, or obstructing traffic is prohibited. Boat trailers may be stored on the grass provided that they are moved onto and off of the grass by hand, or vehicle can do so without getting on the grass.
16. Picnic tables and lantern holders must remain on gravel surfaces at campsites with gravel impact areas.
17. To avoid tree damage, hanging lanterns are to be suspended a minimum of 8" from the side of trees and 24" from overhead limbs. Do not drive axes, nails, or other objects into trees.

CAMPING SCHEDULE/FEEES

CAMPING

Campsites are available on a first-come, first-serve basis unless reserved. Campers must register when placing camping equipment on the site and be ready to camp. Prior to setting up on a reservable site you must see the park attendant and/or book your site prior to setting up. Chaonia Landing Campground only has an honor vault. Island campsite fees can be paid at the Redman Creek fee booth. America the Beautiful (ATB) Senior/ Access Pass and Golden Age/Access pass holders receive a 50% discount on camping fees. The pass holder must be the registered camper and be camping at the site for the duration of stay.

Camping is permitted up to 14 days in a 30-consecutive day period at all campgrounds.

CAMPING RESERVATIONS

Reservations at Redman Creek, Peoples Creek, Greenville and the Islands (Redman Creek) can be made a maximum of 6 months in advance. All campsites at Redman (except islands) and Greenville campgrounds and sites 1-25, 39-57 at Peoples Creek are available for same day reservations and must be booked PRIOR to setting up on. Reservations for all U.S. Army Corps of Engineers reservable campsites can be made by calling 1-877-444-NRRS (6777), or by visiting the NRRS Web Site: www.recreation.gov; or the respective campground fee booth. If you fail to check in by 4pm the day following the first day of your reservation, the site will be classified as a no show and released. **Buddy Sites require payment for both sites.**

PRIMITIVE CAMPING

A northern primitive camping zone has been designated on all Corps public lands south of Hwy 34 to PA 34 (access north of Greenville) on the east side of the St. Francis River and on all Corps public land on the west side, north of where Hwy FF intersects with Hwy 67. Camping in these areas is free and available year round. The southern primitive camping zone includes:

- Areas within 100 feet of 19 designated parking areas south of U.S. Hwy 67 with no facilities.
- Blue Springs and Lost Creek Landing parking areas with grills.
- Sulphur Springs and Possum Creek parking areas with grills and vault restroom.
- Within 100 feet of the Ozark Trail in areas designated above.

PRIMITIVE CAMPERS

Primitive campers are required to register at either the Wappapello Lake Management Office, the Greenville or Redman Creek fee booth, honor vault, or with a park ranger.

- **TRASH:** Please pack out your trash and dispose of it in an approved method.
- **RESTROOM:** If sanitary facilities are not provided, human waste must be buried at least 100 feet from campsites or bodies of water.
- **FIRES:** No ground fires will be permitted unless on a gravel bar or in provided rings. [See Title 36, CFR 327.10(b)]

PARK FACILITIES

BEACHES

Peoples Creek Beach is open from April 24-September 28. Rockwood Point Beach is open from April 24-September 28. Redman Creek Beach is open from April 24-September 28.

GROUP SHELTERS

Group shelters are available on a first come, first served basis unless reserved. The fee for reserving a shelter is \$50 per day. Reservations can be made a minimum of 4 days and maximum of 12 months in advance. Reservations can be made by calling 1-877-444-NRRS (6777), or by visiting the NRRS Web Site: www.recreation.gov, or the respective recreation area campground fee booth.

DAY USE FEES

Boat ramp day use fees are charged at Redman Creek, Rockwood Point, Peoples Creek, Sundowner and both ramps at Chaonia Landing. Beach day use fees are charged at Peoples Creek, Rockwood Point and Redman Creek. Visitors may pay these fees by:

1. Acquiring one of the following passports:

USACE Annual Pass (\$40) - This pass is valid only at USACE projects for which a day use fee is charged.

America the Beautiful (ATB) pass: Interagency Annual (\$80); Senior (one-time \$80 lifetime); Access Pass (disability - free lifetime); Military Annual (active duty - free); Volunteer Pass (250 volunteer hours) and Every Kid in Park - EKIP (free for fourth grade students).

2. A daily day use fee may be deposited in the self-deposit vault at the area or use the automated day use fee machine located near the Visitor Center. A daily fee of \$5 is charged for a private non-commercial vehicle, \$20 for commercial vehicle and \$2 for walk-in or bike-in to use the above boat ramps or beaches. There is no fee for children under 16 years of age.

3. Registered campers at a USACE campground do not have to pay day use fees during their stay. User must display current hang tag from campground.

AMERICA THE BEAUTIFUL INTERAGENCY PASSES

America the Beautiful Passes (Annual, Senior, Access, Military, 4th Grade and Volunteer) can now be obtained/purchased at the Wappapello Lake Management Office and Visitor Center during operating hours.
