- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The unnamed tributary is illustrated on the USGS topographic map. However, the unnamed tributary was not identified or discussed in the February 2012 draft of the Hanson delineation. A field investigation was performed on February 1, 2013. Field observations revealed that the waterbody exists as an apparent excavated field drainage ditch. Aerial photographs dating back to 1990 were reviewed. The channel originates from a topographic drainage pattern in the hillside to the west. In aerial photos, a channel is not visible in the topographic drainage pattern. No channel scars or other remnant features that would indicate a former natural channel were observed. The waterbody was concluded to be a man-made agricultural ditch. Its drainage area was estimated to be about 15 acres.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Explain: **See description in Section II.B.2.** Feature is small, approximately 1 to 2 feet across at the bottom and 20 feet across at the top. The bed substrate of the channel did not appear significantly different than the surrounding farm field soils. The waterbody may have to capability to alter the chemical characteristics of downstream waters by transmitting agrichemicals such as fertilizers and pesticides. However, its drainage area within the farmed field is not well defined. Therefore its physical contribution to downstream waters is undetermined. The waterbody does not appear to have regular flow, as evidenced by vegetation in much of its bed. The waterbody has a very thin riparian corridor, comprised mostly of young scrub woody vegetation. The perceived lack of significant flow within the channel likely inhibits any significant transport of detritus or other aquatic food chain organic base material. The waterbody does not appear to serve any appreciable headwaters functions. For these reasons, the Corps believes that the waterbody does not have a significant nexus to a downstream navigable waterbody.
