**C. Additional comments to support AJD:** [Wetland is fed by drainage from the northwest via a linear wetland feature lacking bed/bank & ordinary high water mark features. Open water wetland was excavated from previous emergent condition and is pumped via a pump station via an underground pipe to Horseshoe Lake to the south. Wetland complex lacks sufficient connection and is therefore a non-adjacent wetland.](#)
