**C. Additional comments to support AJD:** The current site is used for pasture for cattle. Therefore, no issues with wetlands within the project site even though part of the site is floodplain/floodway. There were two drainages that were investigated; located in Table D above. The drainages appeared to be a direct result of the two upland stock ponds located within the property. There was some water flow through each drainage but neither had defined channels and water appeared to only flow when discharged from the ponds.

There is very little forested area within the footprint of the project. The small forested areas within the northern property boundary were investigated and did not contain any drainages/wetlands/waters.
