The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. Summarize overall biological, chemical and physical functions being performed: The wetlands provide some stormwater detention and pollution control. Small vertebrates, amphibians and insects would be expected to prosper in wetland areas. Deer burrows, and deer were observed during the site visit near wetland areas. The wetlands provide habitat and food resources to the local wildlife. The function / benefit in regards to the pollution is that wetlands act as filtration systems, filtering pollutants running off of the adjacent agricultural fields.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

These waterways travel into the unnamed S1 intermittent RPW or S15 perennial RPW, therefore it is the opinion of the Corps that these streams have a significant nexus with the S1 and S15 RPWs. Wetlands WB, WE, WF, WG, WI, WP, and WQ do not directly abut the non-RPWs, but are adjacent. These wetlands are hydrologically connected to RPWs through identified non-RPWs. A map is attached identifying wetland and stream locations. The listed wetlands act as filtration systems, filtering pollutants running off of the adjacent agricultural fields, providing pollution control prior to entering the non-RPWs and ultimately into the RPWs on the site. Additionally, the wetlands provide some stormwater detention and pollution control. Small vertebrates, amphibians and insects would be expected to prosper in these wetland areas. Deer burrows, and deer were observed during the site visit near wetland areas.

The onsite pond, WL (4.65 ac) holds water throughout the year as seen on aerial imagery.
 Tributaries of TNW where tributaries have continuous flow "seasonally" (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: S1 (3,500 linear ft), S2 (1,395 linear ft), and S17 (185 linear ft) are identified in the delineation as intermittent. These streams are not nearly as wide or defined as S15.
