SECTION III: CWA ANALYSIS

Identify TNW: *The Big River. The section of Big River within the review begins at the Rockford mill dam and extends downstream approximately 500 linear feet. The Rockford Beach mill dam is located west of the City of House Springs, Missouri.*

Summarize rationale supporting determination: *The Big River is a perennial channel that has a history of being utilized for kayaking, boating and other recreational activities. About 83 miles of the Big River is navigable by small personal watercraft, year round. Although navigable by small watercraft, portaging is necessary around the 5 historic mill dams that are still present. At this particular location, the river retains a historic mill dam that was originally constructed in the late 1800's. The mill no longer exists but the dam is still present.*

The Big River is a primary tributary to the Meramec River and does have multiple sources of spring and groundwater influence. The Big River is approximately 145 miles in length and has a watershed of 955 square miles. The Big River supports a sport fishing population and supports other fish and wildlife as well. Common sport fish for the river include: Largemouth bass, Smallmouth bass, Spotted bass, Rock bass, Longear sunfish, Bluegill, Channel catfish, Flathead catfish, and Redhorse suckers. In addition, there are mussel beds located downstream of this location.

There is an abundance of public and private access points throughout the length of the Big River. There is one outfitter, known as Cherokee Landing, located in Bonne Terre, Missouri that offers floats along the Big River. Much of the Big River is rated as a Class I floating stream.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
