Ephemeral Stream 1	1,305	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	Ephemeral Stream 1 drains the localized watershed of the immediate hillside acreage of 40 acres. During the site visit the streambed was entirely dry with no isolated pools or signs of sustained hydrology. The USGS Topo maps' contour indicate the topographic relief associated with a drainage feature but no blue line features are mapped in this drainage area. Ephemeral Stream 1 flows in direct response to rainfall and the drainage of the immediately adjacent hillsides. The stream flows into the perennial Mill Creek, which flows into River aux Vases, into Old River slough, and then into (a)1 water, Mississippi River.

B. Typical year assessment(s): The Corps visited the review area on September 11, 2020 which was experienced daily rainfall quantities lower than the 30 year normal range. Although the daily rainfall at the time was below normal ranges the preceding month experienced rainfall quantities well above the normal range and according to the Palmer Index is considered a period of severe wetness. Overall the preceding wet conditions the month prior was balanced by the lower rainfall quantities in the month of September and was considered normal rainfall conditions at the time by the Antecedent Rainfall Calculator.
