C. Additional comments to support AJD: [The drainage feature is a headwater channel that drains an approximate 75-acre agricultural area. The project area exhibits relatively flat topography with some of the historical drainage area affected by I-57 and adjacent roadways. Previous site visits to this area showed that the channel provided no flow and was completely dry. Therefore, the channel was determined to provide ephemeral flow which is exempt under the NWPR \(b\)\(3\).](#)

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
