The ephemeral stream has a relatively small 25 acre watershed that flows in response to precipitation events. There is no evidence of spring or groundwater contributions to the stream's flow. The ephemeral stream flows into an unnamed tributary to Rock Creek. Rock Creek is a primary tributary to the Mississippi River, a navigable waterway.

site evaluation occurred under an unusually dry conditions, however, it was determined that adequate information from the site evaluation and office resources was sufficient to support the determination.

- C. Additional comments to support AJD:** The site conditions found a narrow, high sloped channel with substaintail roots across the channel holding the stream gradients. A elipitcal culvert is immediately upstream of the reviewed length with substaintail riprap placed for approximately 30 feet downstream of the culvert with a substaintail drop of in elevation from the culvert to the lowest riprap to accommodate the sloped landscape. Through the review length the area is at the base of adjacent slope and has discontinuous definition, likely due to alterations from the adjacent residential developments. No areas of pools, groundwater seepage or influence were observed within the review area.
