B. Typical year assessment(s): The channel is approximately 4 feet wide. There is a slight depression that is visible on certain aerials; however, the aerials are not clear enough to determine if any years have water present. During the site visit, the channel did not contain any water flow or pooling. There was vegetation growing within the center of the channel. Due to the lack of water, no aquatic invertebrates were observed. Based on the site visit, the channel appears to only carry flow immediately after a storm event and therefore would be considered an ephemeral stream channel. This channel feeds into Colonial Acres Lake,

a private lake. The lake structure downstream of the site is the likely cause for the buildup of excess material within the channel at this location.

- C. Additional comments to support AJD:** Jason Crites of Missouri Department of Conservation visited the site prior to the Corps involvement. MDC indicated that the drainage is a dry stream channel and that they did not see any further complications with Mr. Withrow cleaning out some of the excess material.
