B. Typical year assessment(s): [The site visit conducted by On-Site Soils was completed when daily rainfall quantities were below the 30 year normal range. The three months prior had varying wetness conditions, that weighted together supported a determination of normal conditions present at the time of the site visit.](#)

C. Additional comments to support AJD: [Erosional rills are present within the review area but not significant enough features to be identified and specifically called out within the AJD as \(b\)\(3\) excluded erosional features. A review of historic aerial photography shows previous filling in this area has occurred but the oldest aerial photos viewed \(1990\) still only show erosional rills in the area. No resources were mapped on the site by USFWS nor USGS; the USDA-NRCS SoilWeb map has non-hydric soils mapped in the project area.](#)

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
