**C. Additional comments to support AJD:** Channel was shown on 1967 topo maps as an intermittent stream, but has not shown up on topo maps as such since. There were pools of stagnant water that had been impounded by rip rap placed in the channel, however, there was no flow entering or leaving the system, nor was there any evidence on the banks of flow such as debris lines or of vegetation laying over due to flow.
