C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: Drainage from the northwest half of the review area, which includes Streams T-1 and T-2, is northward via T-1 to an unnamed tributary of Enon Branch, which discharges to McCoy Creek approximately one river mile before the latter flows into the Cuivre River, and thence to the Mississippi River, a Traditionally Navigable Water. The two tributaries, Stream T-1 and T-2, are first order ephemeral drainages that display an OHWM and continuous bed and bank. At the project location, the tributaries have a drainage area of less than 50-acres. Within the Interior River Lowlands Level III Ecoregion, this drainage area provides surface runoff, which likely aids in establishing intermittent and perennial flows in the downslope tributaries of Enon Branch. During various site visits (8-16-21 & 9-30-21) conducted by the agent, the tributaries exhibited evidence of past flow events and small pools of water with depths ranging from a few inches to approximately 1 foot downslope of the T-1 and T-2 confluence. Site photographs illustrate stagnant, but clear water quality was present in pooled areas during the site visits. The tributaries serve as the downstream receiving area for surface drainage from the agricultural field within the review area. These tributaries serve as conveyance channels capable of transporting nutrients and organic carbon to downstream food webs and receiving waters.
