C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Review area contains four non-jurisdictional aquatic resources. The ephemeral stream has a downstream connection to the TNW (Mississippi River), but its contributions couldn't be more than speculative or insubstantial. The forested and emergent wetlands are depressional, isolated, and have no connection to, or become inundated by, the nearby tributaries or any connection to foreign or interstate commerce. The abandoned farm/stock pond is not considered a water of the US. There are two jurisdictional aquatic resources on this property (both perennial streams) that will be covered under a PJD.
