- **B.** Typical year assessment(s): Antecedent Precipitation vs Normal Range based on NOAA's Daily Global Historical Climatology Network revealed that the Corps' site visit on March 1, 2021 took place during the wet season but was experiencing normal conditions at that time.
- **C.** Additional comments to support AJD: During the site visit, the Corps noticed that the bed and bank features were that of an epehermal drainage. The leaf litter was not being transported like what intermittent and perennial flows would achieve. There were tree roots observed within the bed of the
