Summarize overall biological, chemical and physical functions being performed: The wetland contributes surface flows to the tributary to Peruque Creek. The wetland provides water filtration, wildlife habitat and sediment retention for the surrounding watershed. Water exits the wetland through the tributary to Peruque Creek.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** As documented in Section F "Other": The delineation summary report documented four (4) features including Agricultural Ditch, Relic Drainage Ditch and Wetland, and borrow Lake that were determined to be non-jurisdictional. The borrow lake was excavated in an upland agricultural setting for fill material for the adjacent waste water treatment facility construction between 1996 and 2002. The relic drainage ditch and wetland were historically part of the drainage system for Highway 79; however, upstream and downstream reaches of the ditch have been impacted and effectively eliminated, isolating the features and routing hydrology elsewhere. The constructed agricultural ditch increases drainage from the existing irrigated sod field downslope to the borrow lake. The feature was excavated wholly in and draining only uplands and does not carry a relatively permanent flow of water.
