MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ MVS-2024-159

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable for Missouri, due to litigation.

- 3. REVIEW AREA. The project site is a 155-acre parcel located at Latitude 38.8303, Longitude -90.3367, St. Louis County, Missouri.

A previous Approved Jurisdictional Determination was conducted by Chad Lamontagne of the Corps, dated 6/14/2021 (Corps File Number MVS-2021-336). The determination was provided during the Navigable Waters Protection Rule era. The JD produced one ephemeral stream channel (Stream 1) onsite, that was considered non-jurisdictional at that time. A pond was subsequently built on the headwater of Stream 1 and no permit review was required.

- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The site is located within the Missouri River watershed. The Missouri River is a large, perennial interstate water that provides for barge and water recreation activities. The Missouri River also supports a large diversity of aquatic fish and invertebrates and a fishing industry.
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS Lawnview Creek North Branch is located along the eastern property boundary. Lawnview Creek flows into Coldwater Creek, a primary tributary to the Missouri River.

 - Stream 1: The drainage is a non-relatively permanent waterbody that only flows after rainfall events. The 1,200 linear foot feature is ephemeral and is located at the top of a 30-acre watershed and is routinely farmed through. The drainage is located within the northwestern portion of the site. Stream 1 is a first order, non-navigable tributary and is not jurisdictional. The flow regime was analyzed at the furthest downstream portion of the first order reach, and it was consistent throughout.
 - ii. Stream 2: The drainage is a non-relatively permanent waterbody that only flows after rainfall events. The 1,770 linear foot feature is ephemeral and is



within a 115-acre watershed with a 1.7% slope. The drainage is located along the eastern property boundary of the site. Stream 2 is a second order, non-navigable tributary and is not jurisdictional. The flow regime was analyzed at the furthest downstream portion of the first order reach, and it was consistent throughout.
