MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 MVS-2024-371

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA), the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Missouri due to litigation.

1. SUMMARY OF CONCLUSIONS.



- 3. REVIEW AREA. The project includes a 10' wide walk/trail on the south side of the park roadway. Approximately 163 square feet of fringe wetland exists on the north side of the South Lake. The work within the wetland is less than 0.5-acres.
 - Latitude 37.3453, Longitude -89.5916, City of Cape Girardeau, Cape Girardeau County, Missouri.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The project is within the Mississippi River watershed. The Mississippi River is a perennial stream source that offers interstate transport as well as provides for recreational watercraft. The Mississippi River also has habitat that supports a diverse fisheries and other various aquatic species.
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

The North and South Ponds are located above an unnamed tributary to Ramsey Branch, which flows into the Headwater Diversion Channel, a primary tributary to the Mississippi River.


- i. South Lake: The lake is located within the uplands and was man-made, for aesthetic and recreation purposes for the Cape Girardeau County Park. The lake is approximately 1.6-acres. The lake drains to the south where is forms into an unnamed tributary to Ramsey Branch.
- ii. South Lake Wetland: Exists within the north end of South Lake. The South Lake Wetland exists as a fringe wetland where the water flow enters the lake through a culvert from the North Lake. The wetland exists within the Ordinary High Water of the lake and therefore part of the lake itself.
- b. Describe aquatic resources and features within the review area identified as "generally not jurisdictional" in the *Rapanos* guidance. 
