#### MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), <sup>1</sup> MVS-2024-301

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA), the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable Missouri due to litigation.

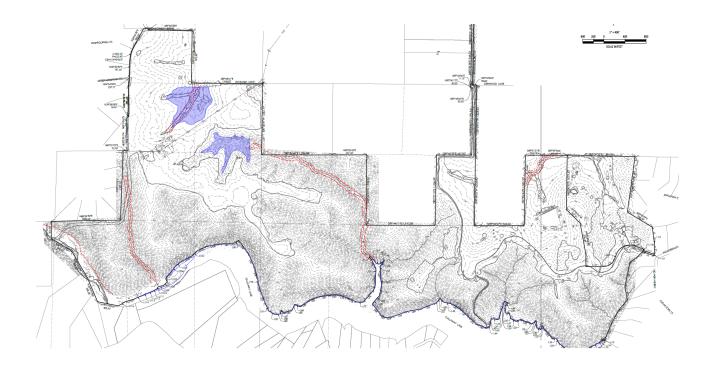

- 3. REVIEW AREA. The project site is a total of 690-acres, Latitude 38.6910, Longitude -90.8661, near the town of Defiance, St. Louis County, Missouri.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. There is a drainage divide within the site and two of the drainages are part of the Mississippi River watershed and two of the drainages are part of the Missouri River watershed.

The Mississippi and Missouri Rivers are both navigable waters that are utilized both for the movement of goods on barges as well as for personal watercraft. The Mississippi and Missouri Rivers are also waters that contain diverse habitat for fisheries and various aquatic species.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

Streams A and C are tributaries to Callaway Lake, which was created by an impoundment of Callaway Fork. Callaway Fork flows into Femme Osage, a primary tributary to the Missouri River.

Streams B and D are tributaries to Cunningham Branch, which flows into Dardenne Creek, a primary tributary to the Mississippi River.

- f. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the pre-2015 regulatory regime consistent with the Supreme Court's decision in *Sackett* (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).
  - i. Stream A: Is located at Latitude 38.6933, Longitude -90.8776. Stream A is approximately 2,500 linear feet in total length with a 53-acre watershed. The tributary is a non-relatively permanent waterbody that only flows after rainfall events. Stream A is a first order, non-navigable tributary and is not jurisdictional. The flow regime was analyzed at the furthest downstream portion of the first order reach, and it was consistent throughout.
  - ii. Stream B: Is located at Latitude 38.7013, Longitude -90.8736. Stream B is approximately 2,700 linear feet in total length with a 102-acre watershed. The tributary is a non-relatively permanent waterbody that only flows after rainfall events. Stream B is a first order, non-navigable tributary and is not jurisdictional. The flow regime was analyzed at the furthest downstream portion of the first order reach, and it was consistent throughout.
  - iii. Stream C: Is located at Latitude 38.6948, Longitude -90.8675. Stream C is approximately 4,200 linear feet in total length with a 204-acre watershed. The tributary is a non-relatively permanent waterbody that only flows after rainfall events. Stream C is a first order, non-navigable tributary and is not jurisdictional. The flow regime was analyzed at the furthest downstream portion of the first order reach, and it was consistent throughout.
  - iv. Stream D: Is located at (downstream: 38.6986, -90.8487; upstream: 38.6961, -90.8570). Stream D is approximately 2,500 linear feet in total length with a 166-acre watershed. The tributary is a non-relatively permanent waterbody that only flows after rainfall events. Stream D is a first order, non-navigable tributary and is not jurisdictional. The flow regime was analyzed at the furthest downstream portion of the first order reach, and it was consistent throughout. The soils within this reach are mapped as well drained, Sensabaugh gravelly loam.
