MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 MVS-2024-333.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

- 3. REVIEW AREA. The review area is limited to the area of disturbance for the construction of TRRA's new railroad loop, an approximately 30 acre area. The review area is located in Venice, Madison County, Illinois. See "TRRA Wetland Impact Overlay" attachment for the extent of the review area. The area is currently utilized for agricultural purposes. There is a total of 1.778 acres of wetlands in the review area, all of which are proposed to be impacted.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), THE TERRITORIAL SEAS, OR INTERSTATE WATER TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The Mississippi River is the nearest TNW. The Mississippi River has a navigation channel maintained by the Army Corps of Engineers.⁵
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, THE TERRITORIAL SEAS, OR INTERSTATE WATER. The review area does not flow to a TNW, as the review area is located within a depressional topographic setting.

A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

Wetland 4 - Wetland 4 is a depressional area which does not have a continuous surface connection, does not flow out of the delineated area in any way nor does any discrete feature enter or exit Wetland 4. There, Wetland 4 does not have a continuous surface connection to a jurisdictional water.

Wetland 5- Wetland 5 is a depressional area which does not have a continuous surface connection, does not flow out of the delineated area in any way nor does any discrete feature enter or exit Wetland 5. There, Wetland 5 does not have a continuous surface connection to a jurisdictional water.

Wetland 6 - Wetland 6 is a depressional area which does not have a continuous surface connection, does not flow out of the delineated area in any way nor does any discrete feature enter or exit Wetland 6. There, Wetland 6 does not have a continuous surface connection to a jurisdictional water.
