MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ MVS-2024-526.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable Missouri due to litigation.

- 3. REVIEW AREA. The Review Area is a 9.54 acre area located at 6101 Ozark Way, Weldon Springs, Missouri. Approximate geographic coordinates of the site are 38.723983, -90.682311.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The Mississippi River is the nearest downstream TNW. The Mississippi River has a navigation channel maintained by the Army Corps of Engineers.
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS The unnamed tributary onsite flows offsite into Crooked Creek. Crooked Creek flows into Dardenne Creek. Dardenne Creek flows into the Mississippi River.

 - e. Tributaries (a)(5): MVS-2024-526 Stream 1 MVS-2024-526 Stream 1 is a Relatively Permanent Water (RPW) that has flowing or standing water yearround or continuously during certain times of year. MVS-2024-526 Stream 1 at the point it exists the Review Area has a watershed size of approximately 122 acres. Photos included in the Wetland Delineation report show water in MVS-2024-526 Stream 1, as does Google Streetview from March 2022 and October 2012. Leafoff imagery from Google Earth shows water in MVS-2024-526 Stream 1 in March 2024, March 2022, February 2018, April 2016, April 2010, April 2007, April 2004, and March 2003. The flow characteristics observed over the 20 years are representative of the entire reach of the feature and supports the conclusion the tributary flows more than seasonally and more than in direct response to precipitation.
