MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), [MVS-2024-554](#)

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>1</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>2</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>3</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable [[in Missouri](#)] due to litigation.

non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

**Tributary A** (~775 linear feet) is a stream channel that would flow to an unnamed tributary when the channel has surface discharge. Tributary A originates from a culvert conveying drainage underneath Hawk Circle Drive where the stream channel gains definition within a forested draw. Tributary A drains an approximately 32-acre watershed and likely receives short duration, flashy flows following rain events. Tributary A has a 4% slope (31' of fall in 775 feet of distance), which is too steep to maintain relatively permanent flow at this location. The channel had slight flow at the time of the site visit (USACE – 12/6/2024), however the APT indicated wetter than normal conditions during the wet season. There was a small pool with standing water below a head-cut towards the upper end of the reach. Furthermore, the channel did not contain a consistent low-flow channel or thalweg, and channel characteristics appeared to have developed by the repeated sequence of flashy streamflow, flow cessation, and channel drying throughout the year. Much of the stream channel had leaf wracking on the upstream side of rocks/debris indicative of the lack of consistent flows. The unnamed tributary likely does not flow seasonally and was determined to be a non-relatively permanent water.

10. OTHER SUPPORTING INFORMATION. A review of USGS topographic maps from 1972-2000 do not indicate a mapped blue-line feature in the location of Tributary A. The unnamed tributary that receives Tributary A is present as a mapped blue-line feature. In addition, the MO WQS Stream Classification 2019 data layer on the NRV does not indicate a stream feature in the location of Tributary A. Furthermore, a stream feature is not indicated on the NWI, NHD, or USGS Topo maps in the location of Tributary A.

The Corps visited the site on December 6, 2024, during wetter than normal conditions during the wet season, with the drought index indicating normal conditions.

11. NOTE: The structure and format of this MFR were developed in coordination with the EPA and Department of the Army. The MFR's structure and format may be subject to future modification or may be rescinded as needed to implement additional guidance from the agencies; however, the approved jurisdictional determination described herein is a final agency action.
