MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ [MVS-2025-490] [MFR 1 of 1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

- f. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the pre-2015 regulatory regime consistent with the Supreme Court's decision in *Sackett* (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Unnamed tributary 1 (UNT 1) is an ephemeral stream that is approximately 776 linear feet within the project area and entirely adjacent to Romaine Creek Road. The substrate consists of silt, sand, and gravel, apart from a 125-foot segment west of Spring Valley Drive. It is approximately 0.5-foot deep and 3.5 feet wide at the ordinary high water mark within the project area. UNT 1 is not mapped on USGS Stream Stats. A portion of a mapped stream outside of the project area drains to UNT 1 via storm sewer. After the mapped stream crosses Romaine Creek Road, it appears to have been re-located along Romaine Creek Road, which was identified as UNT 1. Therefore, the drainage area at the most downstream location of UNT 1 within the project area would be more than the drainage area measured by Stream Stats: 0.0543 square mile. Based on the steep topography and nearby proximity of Sugar Creek adjacent to the project area, it is estimated that the drainage area of UNT 1 is less than 0.1 square mile.

The stream is considered a non-relatively permanent water; therefore, it is not considered federally jurisdictional as defined by (a)(3) of the 2023 Revised Definition of "Waters of the United States" Rule.

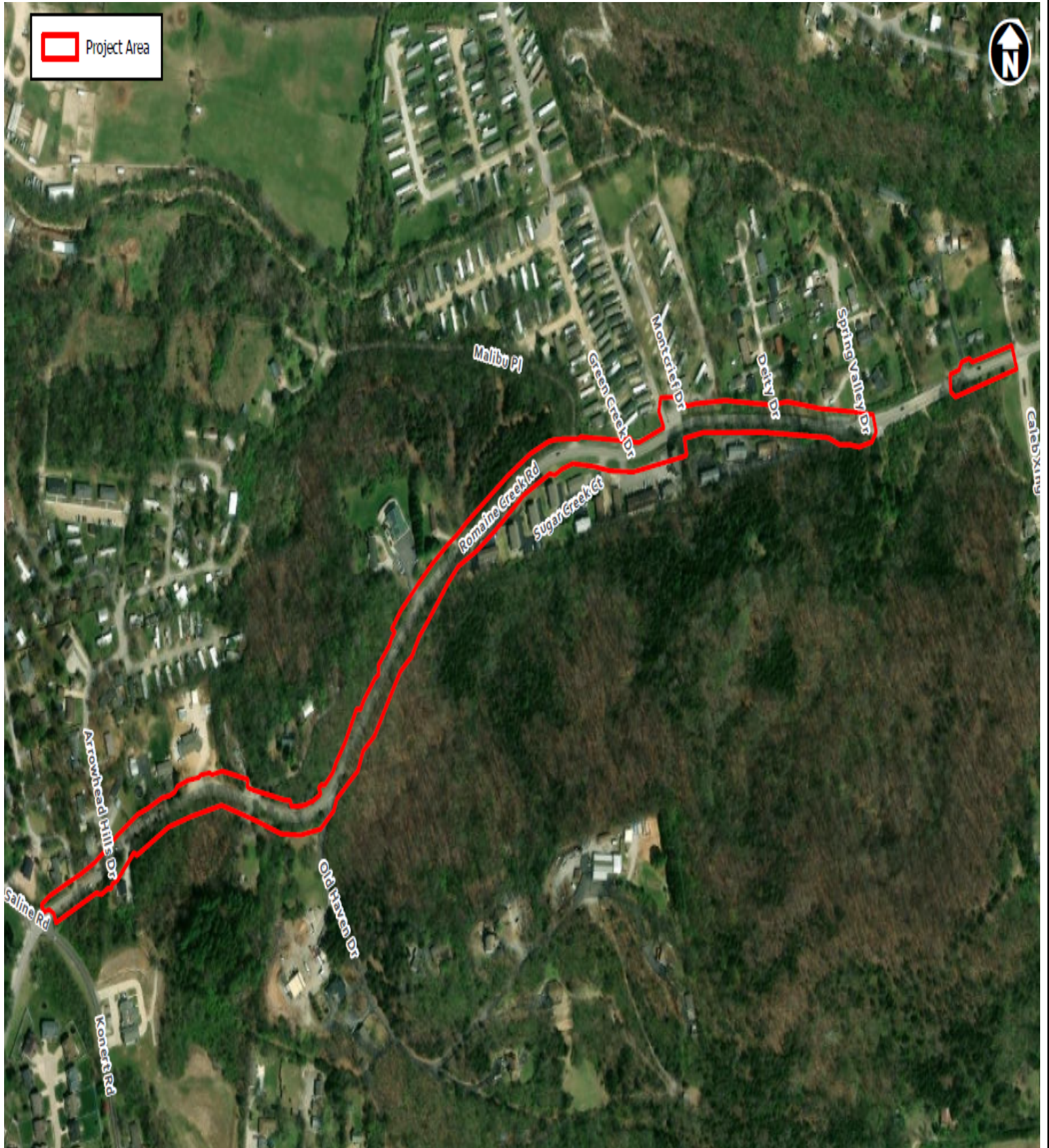

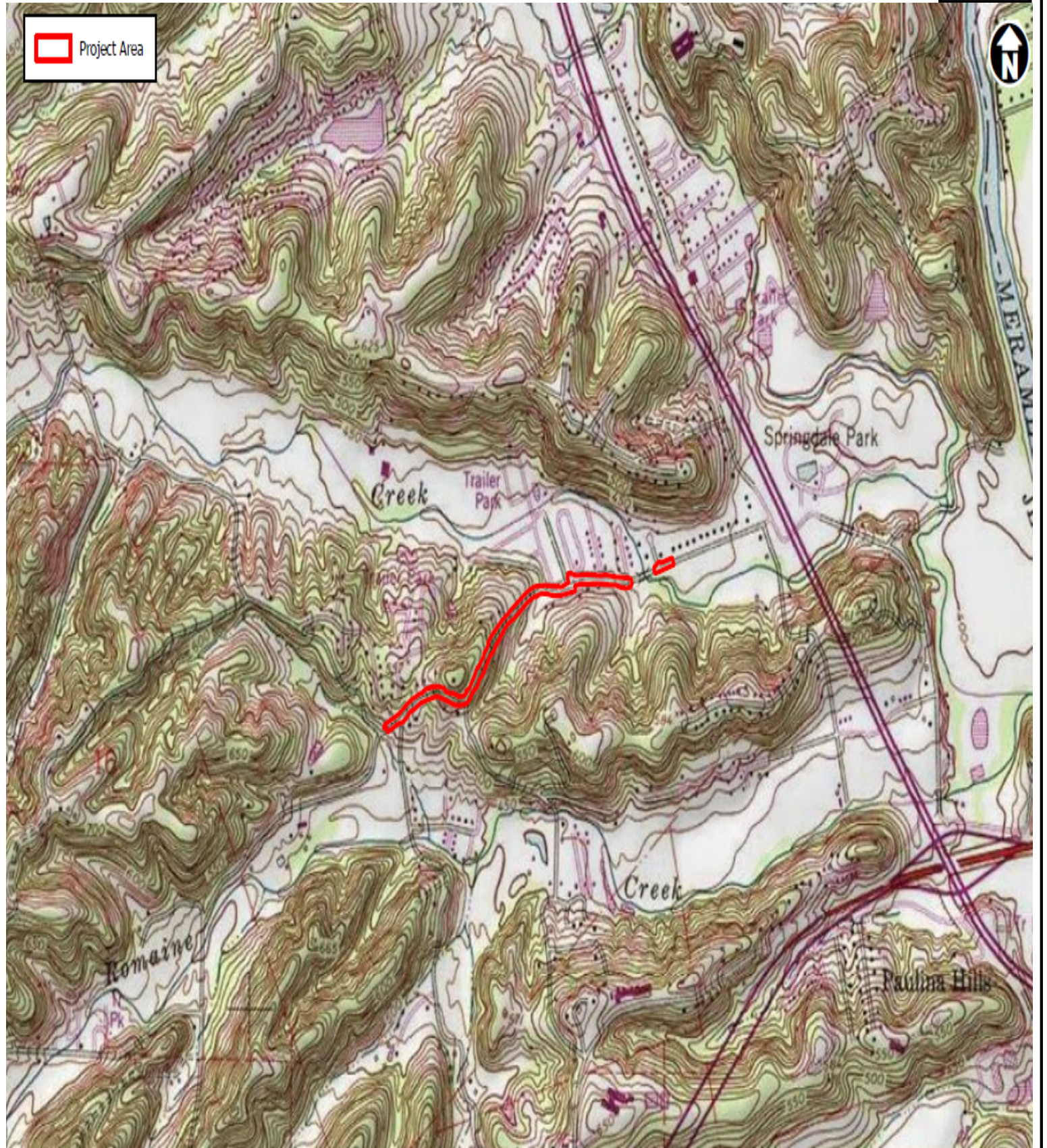

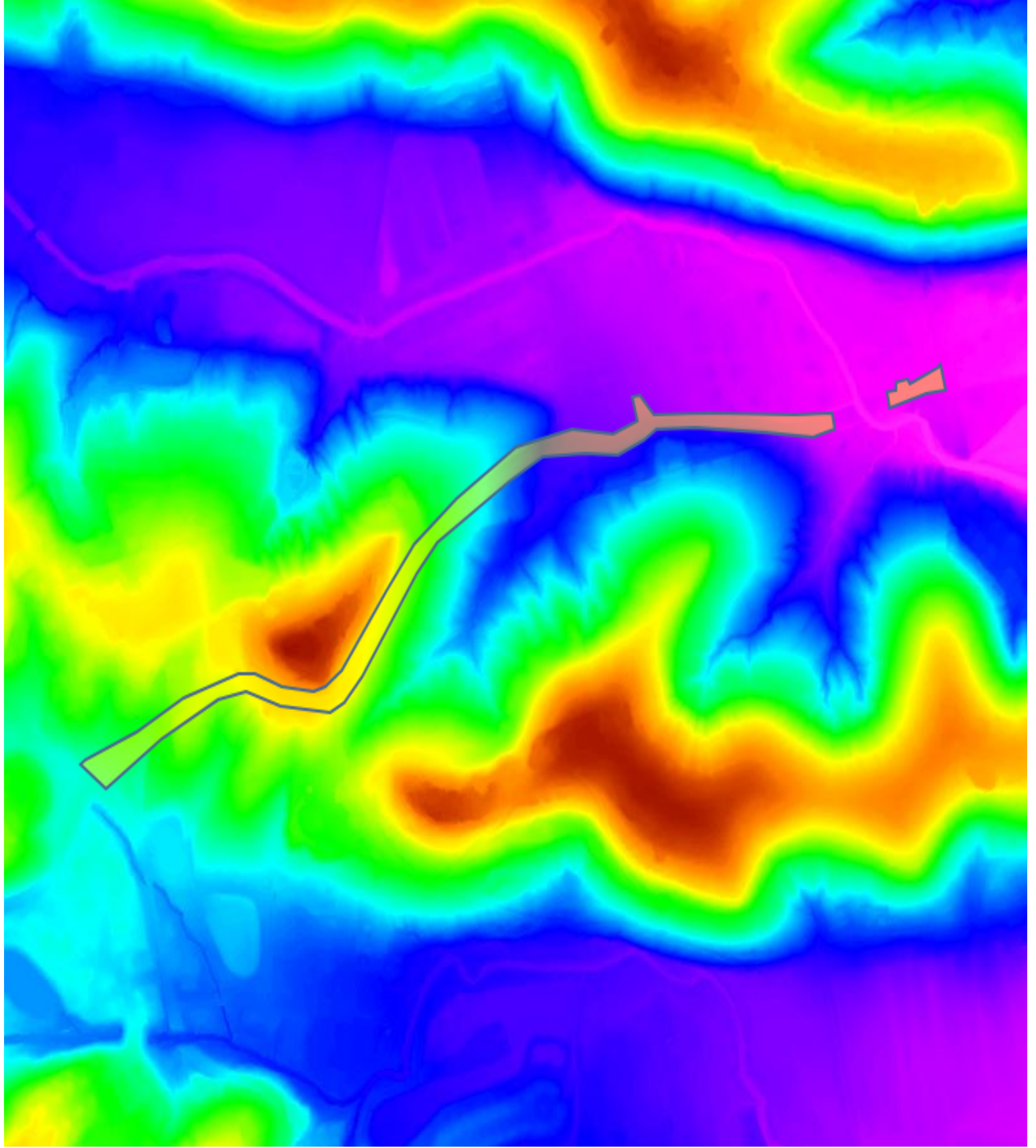


 Project Area



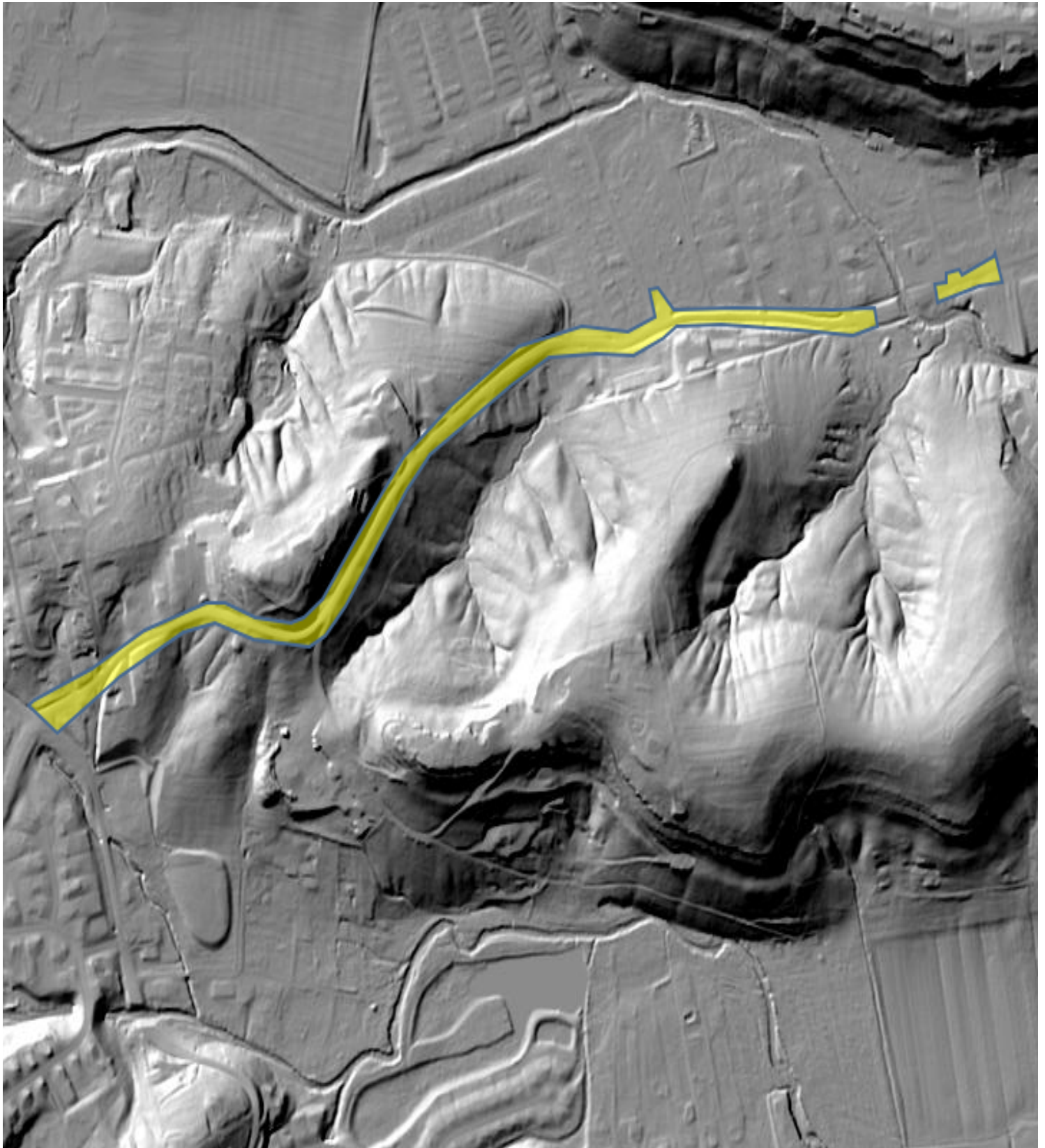

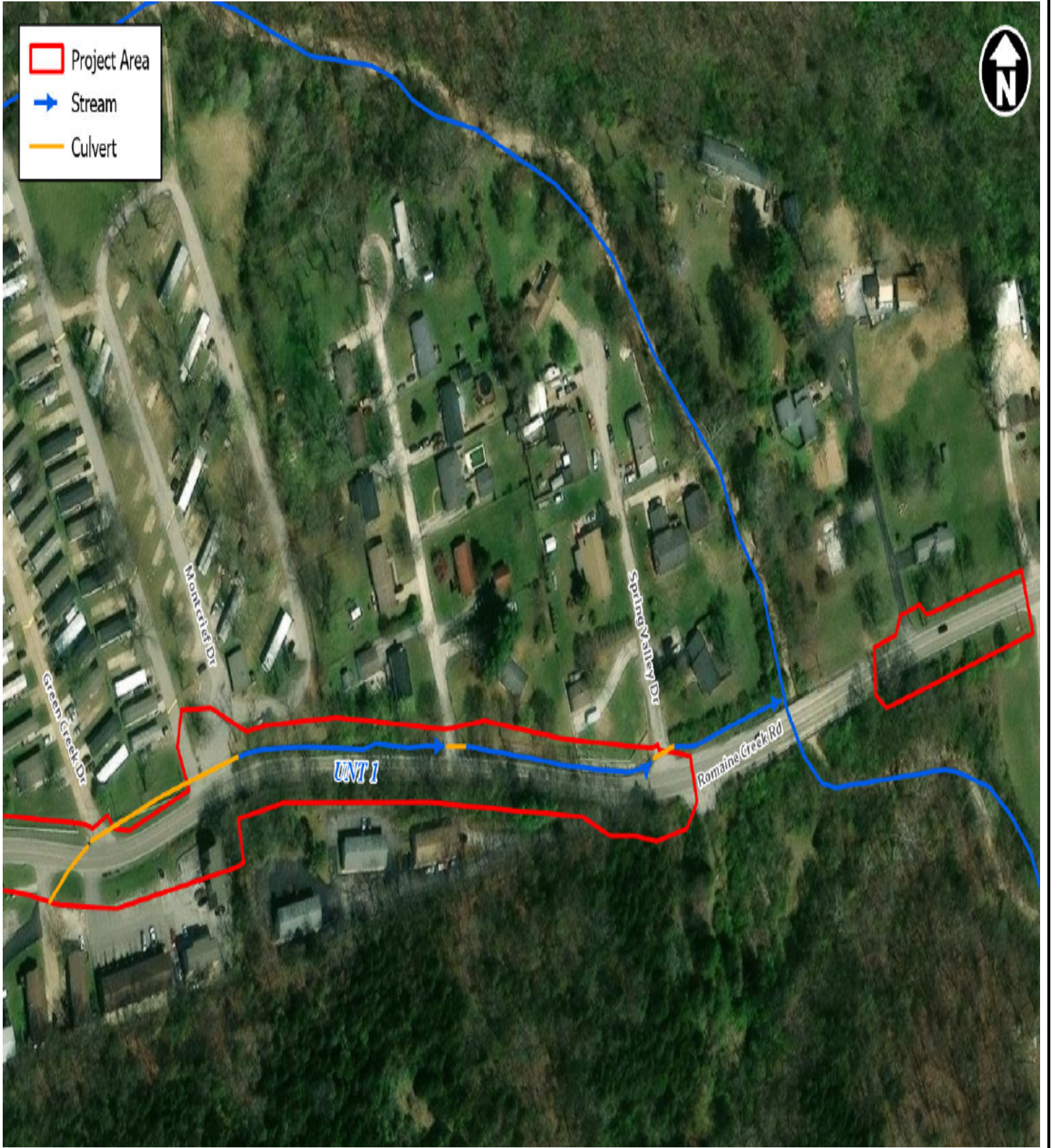
