MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ MVS-2025-624²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

² When documenting aquatic resources within the review area that are jurisdictional under the Clean Water Act (CWA), use an additional MFR and group the aquatic resources on each MFR based on the TNW, interstate water, or territorial seas that they are connected to. 3. REVIEW AREA. The approximately 29-acre site located Land Grants 206 and 2030, Township 45 North, Range 4 East in the City of Chesterfield, St. Louis County, Missouri. The site is located approximately 0.7 miles southeast of the right descending bank of the Missouri River. The property comprises steeply sloping wooded bluffs above the Missouri River floodplain. Hog Hollow Road, a steep, surfaced, two-lane link between the Missouri River bottoms in Maryland Heights and Olive Boulevard in Chesterfield, is located partly within and partly adjacent to the southwest side of the subject site. The road approximately parallels an unnamed intermittent stream that flows from under Olive Boulevard to a tributary of the Missouri River. The subject site is generally bounded by residential and commercial properties to the east and west; Olive Boulevard to the south; and a railroad track and Water Works Road to the north. The vicinity of the site is characterized by residential and commercial properties. To the north is largely agricultural, except for a St. Louis County water treatment plant located immediately below the river bluffs. 38.6816, -90.5197

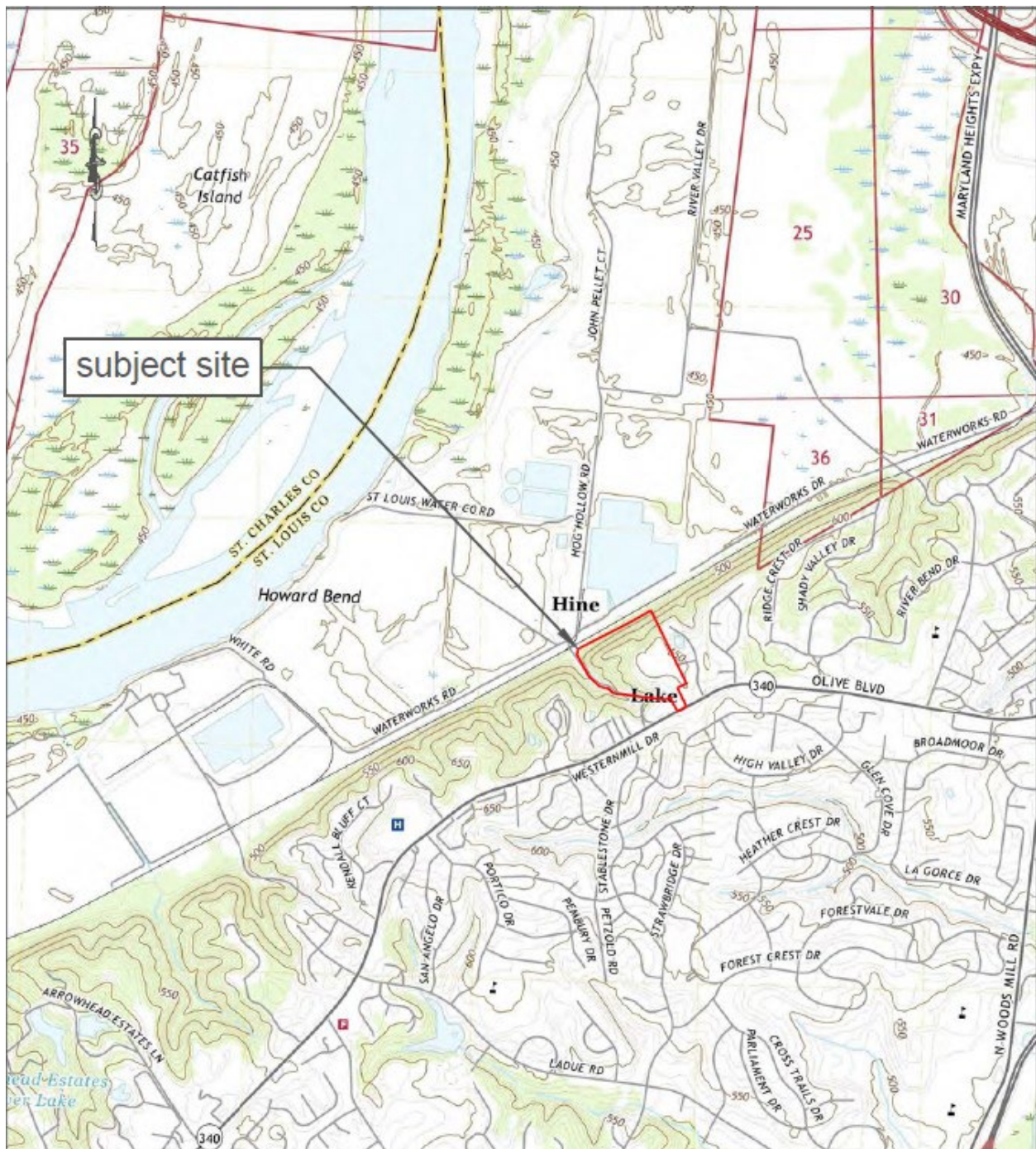


Figure 2: Location Map

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED.⁶ The Missouri River, which is a TNW throughout the MVS footprint.
5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. Water leaves the site via a series of swales, and erosional features into Hog Hollow Creek, which flows into the Missouri River.

⁶ This MFR should not be used to complete a new stand-alone TNW determination. A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

⁷ 33 CFR 329.9(a) A waterbody which was navigable in its natural or improved state, or which was susceptible of reasonable improvement (as discussed in § 329.8(b) of this part) retains its character as "navigable in law" even though it is not presently used for commerce, or is presently incapable of such use because of changed conditions or the presence of obstructions.

Several side channels were identified along the southern and western areas of the review area. They lack bed/bank and OHWM features, exhibiting characteristics of erosional features, such as steep slopes, and highly eroded banks.

resource or feature, and how it was determined to be an “isolated water” in accordance with SWANCC. N/A
