MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ MVS-2026-133 MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

3. REVIEW AREA. The AJD review area is located along the northwestern section of the Wright City Rest Area along Interstate 70 and north of North Service Road, Warren County, Missouri [Latitude: 38.829408, Longitude: -91.055136].

The JD review area is approximately 4.75 acres (see attached map).

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The Mississippi River is the closest downstream TNW to the water listed above in Section 1. a.⁶
5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. Wetland 1 within the review area does not connect with a RPW, however in an extreme event, sheetflows would drain from this feature west into a stream that connects with Indian Camp Creek. Indian Camp Creek flows east into Big Creek, which flows east into the Cuivre River. The Cuivre River flows east into the Mississippi River (TNW).
6. SECTION 10 JURISDICTIONAL WATERS⁷: Describe aquatic resources or other features within the review area determined to be jurisdictional in accordance with Section 10 of the Rivers and Harbors Act of 1899. - f. Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the pre-2015 regulatory regime consistent with the Supreme Court’s decision in *Sackett* (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

Wetland 1: The wetland within the review area is a historic sewage lagoon site, that has been decommissioned, and measures 3.47 acres. There is an existing berm around the entire perimeter of the wetland site and has no hydrologic connection to downstream waters. Wetland 1 does not abut an RPW.

- A review of aerial and topographic maps indicates that the nearby mapped aquatic resources are not connected to the wetland boundary.
- A review of Missouri Elevation Hillshade and DEM (LiDAR Shaded Relief) indicate that the wetland is a depression on the landscape. LiDAR did not indicate the presence of any features that would suggest potential surface connections between the wetland and another water of the U.S.
- Wetlands 1 is not paragraph (a)(1) TNWs, is not paragraph (a)(2) interstate waters (i.e., they do not cross or serve as a state boundary), is not (a)(3) waters (i.e., lakes or ponds that support a link to interstate or foreign commerce because they are known to be used by interstate or foreign travelers), is not paragraph (a)(4) impoundments of a water of the U.S., is not paragraph (a)(5) tributaries, and is not paragraph (a)(6) territorial seas.

Army/EPA Memorandum to the field concerning the proper implementation of “continuous surface connection” under the definition of “waters of the United States” under the Clean Water Act (March 12, 2025) explains that “consistent with *Sackett*, the agencies are interpreting “waters of the United States” to include “only those adjacent wetlands that have a continuous surface connection because they directly abut the [requisite jurisdictional water] (e.g., they are not separated by uplands, a berm, dike or similar feature).” 2008 Rapanos Guidance at 7, footnote 29; see also 88 FR 3090 (Jan. 18, 2023) Considering the lack of connection between the wetland and the nearest RPW, this wetland does not have a continuous surface connection with the downstream relatively permanent tributary and, consistent with *Sackett*, is not “adjacent.” As such, Wetland 1 is not a jurisdictional water.
