MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ [MVS-2026-94](#)

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable [in Missouri](#) due to litigation.

1. SUMMARY OF CONCLUSIONS.

The unnamed tributary to Glaize Creek does exist as a blue-line channel and is identified on the NHD layer as an intermittent stream channel. The drainage feature starts to the west of the site and flows east through the site for approximately 600 linear feet. The drainage feature was observed to have some sections of pooling but no consistent flow was evident during the consultant's site visit conducted on March 8, 2026. A review of the APT for the date of the site visit showed that there was a significant rain event that occurred prior, during and after the site visit. The drainage feature does not have continually flow at least seasonally, as evident from the lack of flow throughout the channel at the time of the site visit, during a significant rain event. Flow regime was assessed at the lowest downstream portion of the reach and flow conditions remained consistent throughout. The drainage feature has an approximate 77-acre watershed and contains features typically associated with intermittent streams, including inconsistent channel features. The drainage features is considered a non-relatively permanent aquatic feature.

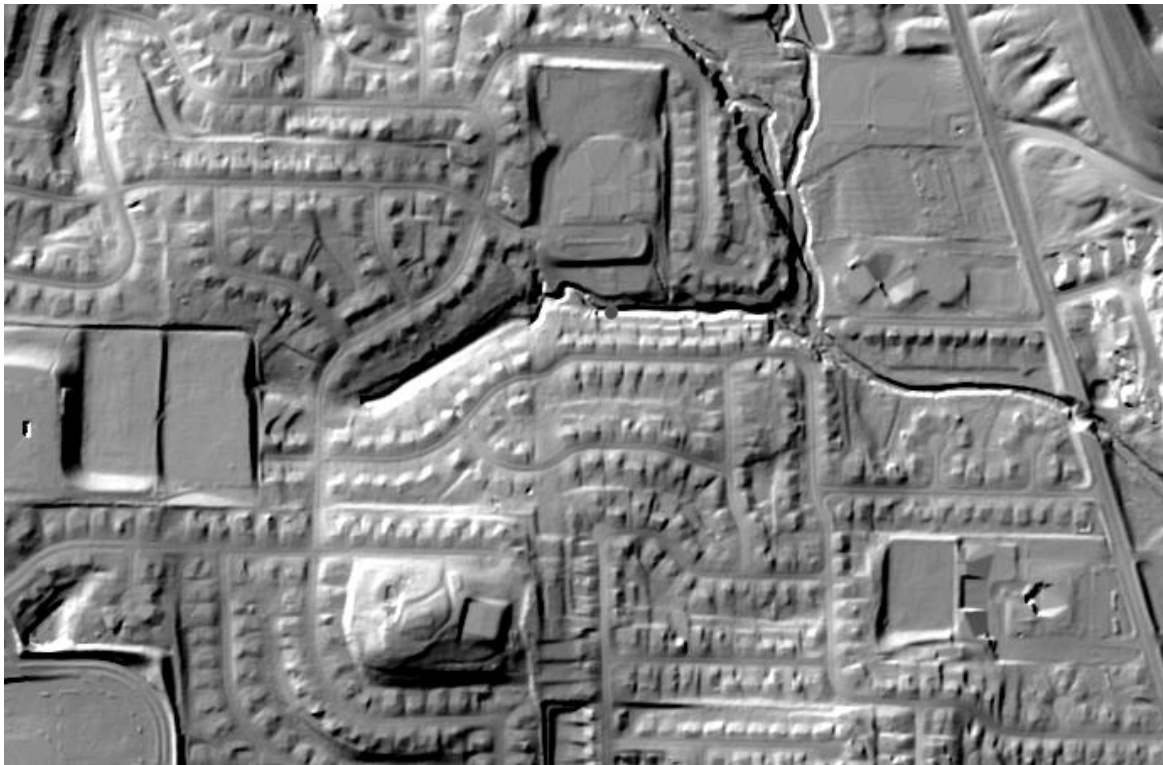
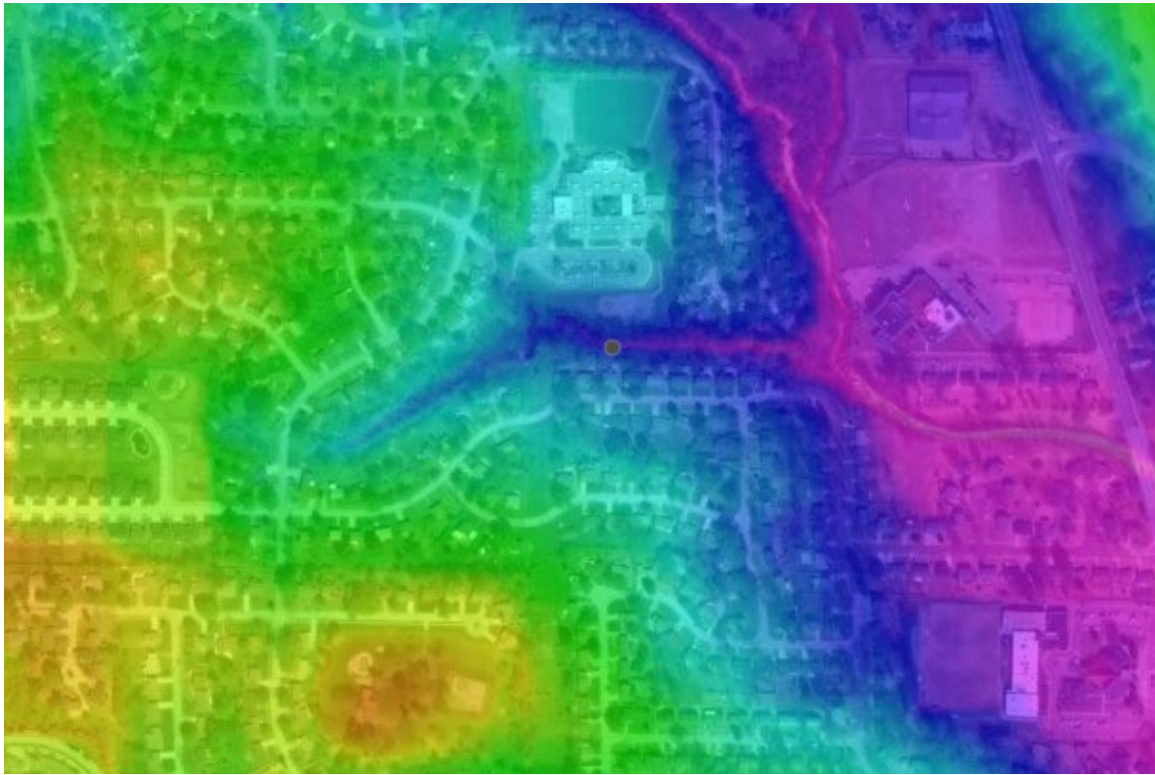
