### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

At the project location, Leatherwood Creek has a drainage area of approximately 8,000 acres, or about 12.5 square miles. Within the Ozark Highlands Ecoregion, this drainage area provides ample runoff and groundwater influence to establish perennial flow. During site visits conducted on November 4<sup>th</sup> and 8<sup>th</sup> of 2016, the creek exhibited discernible flow, with depths ranging from a few inches to approximately 6 feet in deeper pools. At the time of the site visits, the water appeared exceptionally clear, indicating groundwater influence. The creek likely experiences significant rises in flow following rain events. Debris and drift lines occurred in the streamside vegetation. The creek also supports populations of benthic macroinvertebrates, such as caddisfly and mayfly larvae. Numerous minnows occupied the project reach. The property owner states that game fish species also occur within the project reach.](#)
