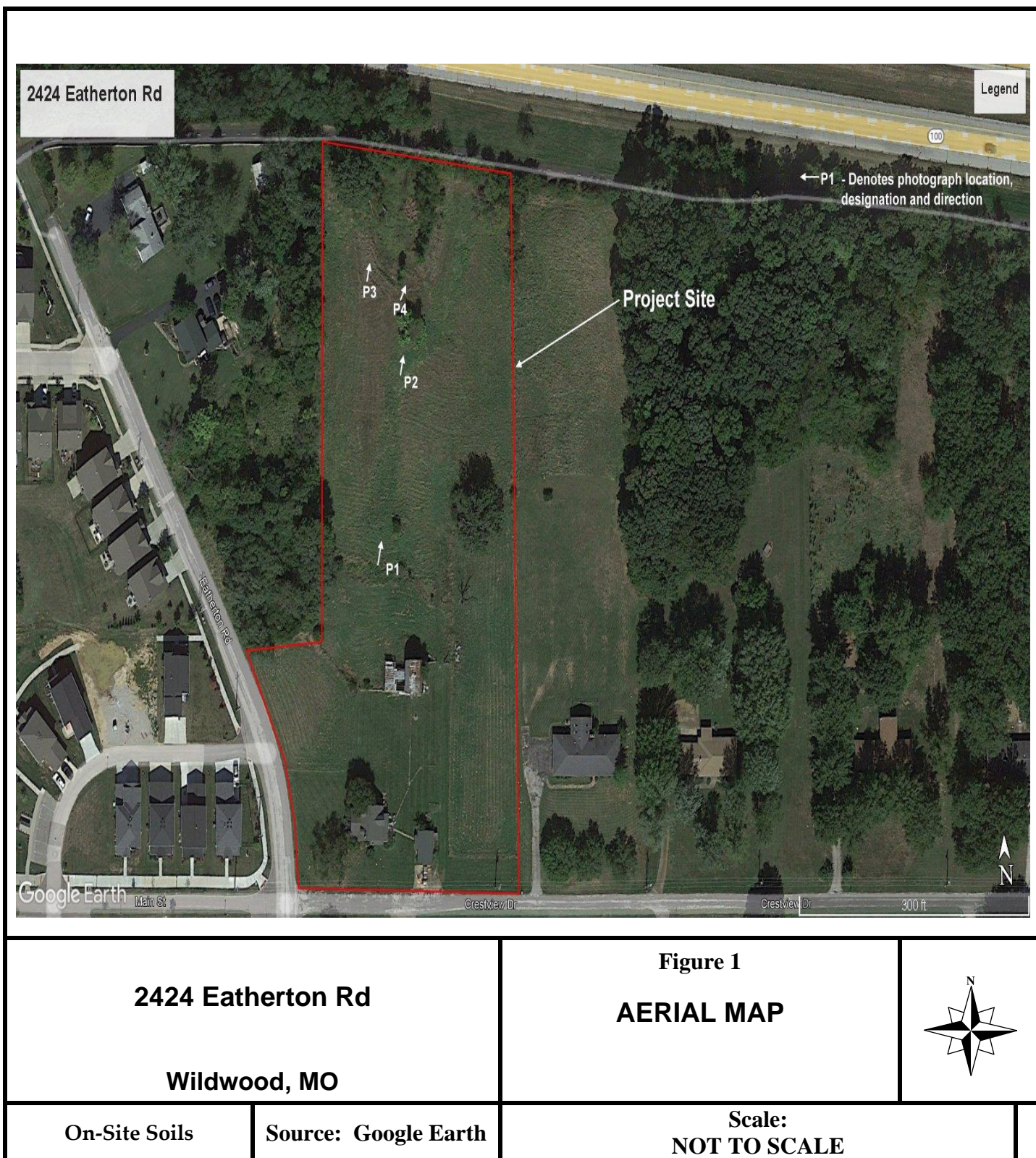

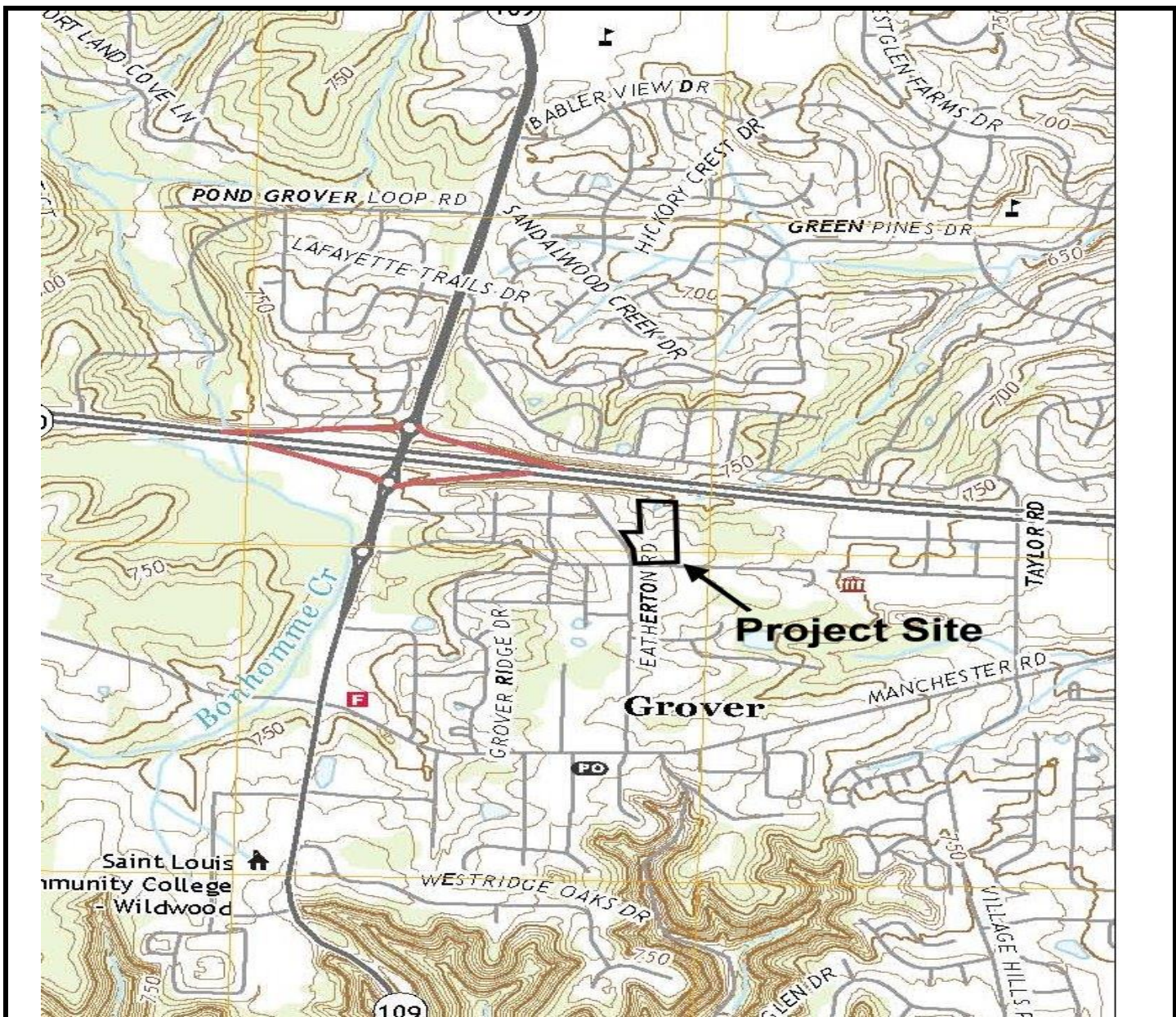

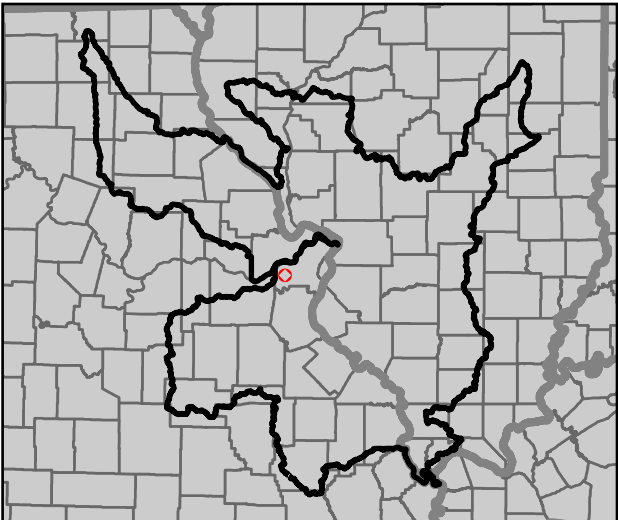




<b>2424 Eatherton Road</b>  <b>Wildwood, MO</b>		<b>Figure 1</b>  <b>USGS MAP</b>
