MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ MVS-2024-203

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Missouri due to litigation.

1. SUMMARY OF CONCLUSIONS.

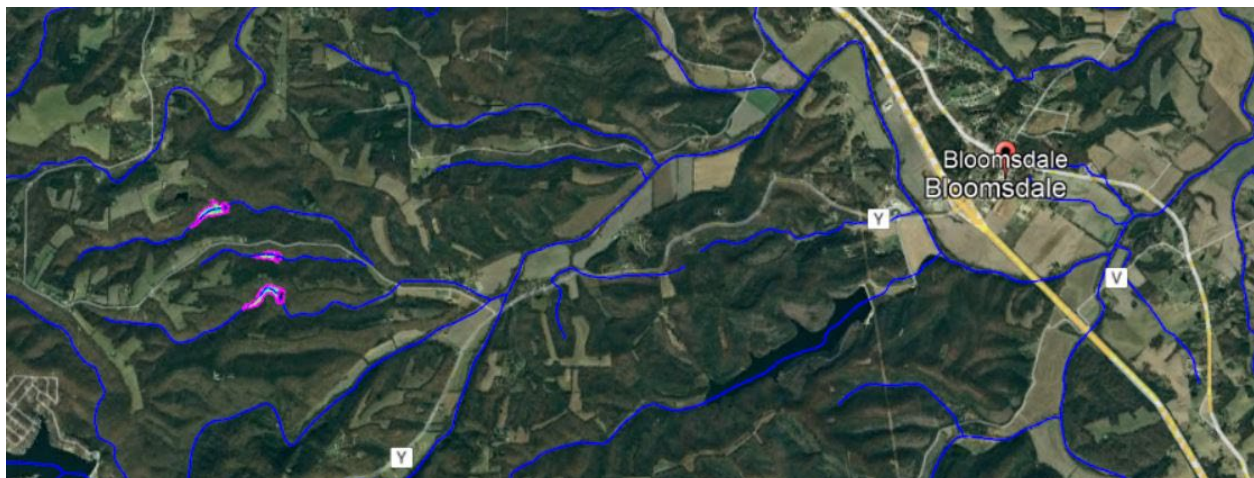

3. REVIEW AREA. Review area includes three adjacent unnamed ephemeral tributaries approximately 4-miles west of Bloomsdale, Ste Genevieve County, Missouri. 38.0008, -90.3005.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Mississippi River.

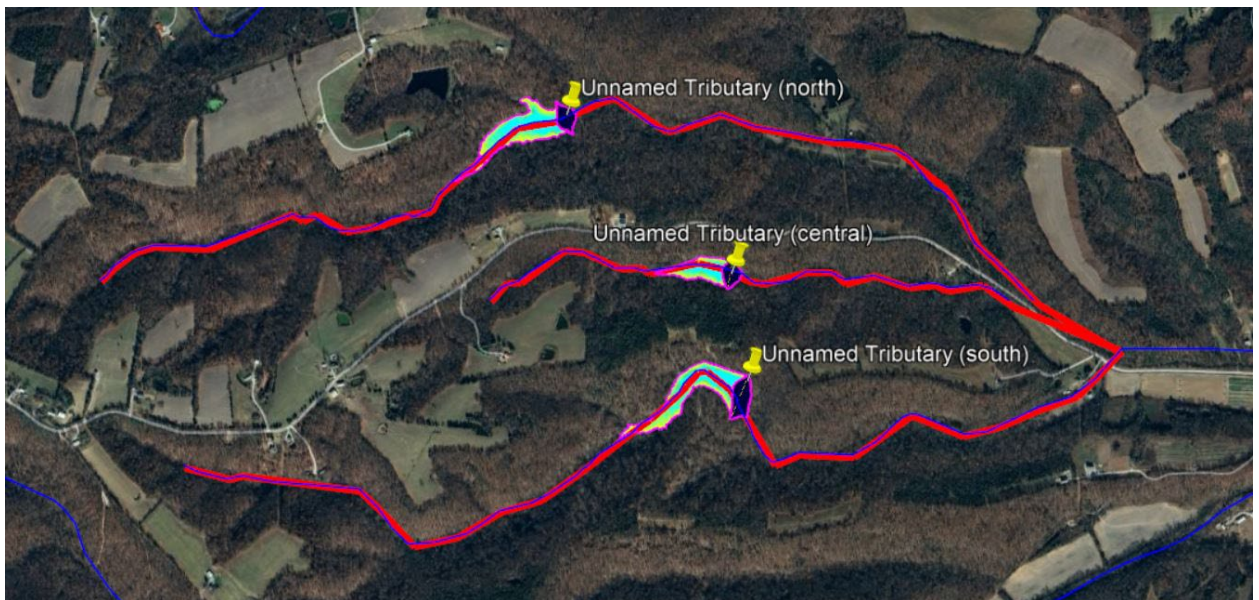
Unnamed Tributary (north): ~12,309 linear feet, 320-acre watershed, 4' wide x 6" deep channel with poorly defined bed/bank features. Large rocky substrate in channel. Soil is well drained, gravely silt loam that does not exhibit continuous seasonal flow. Unnamed Tributary (north) is a 1st order ephemeral stream. No water was present in the channel during the site visit, which occurred during the wet season with drier than normal conditions. The flow regime was analyzed at the furthest downstream reach, and the flow characteristics are consistent the entire length, therefore it was determined to be a non-relatively permanent tributary.

Unnamed Tributary (central): ~7,024 linear feet, 121-acre watershed, 3' wide x 6" deep channel with poorly defined bed/bank features. Large rocky substrate in channel. Soil is well drained, gravely silt loam that does not exhibit continuous seasonal flow. Unnamed Tributary (central) is a 1st order ephemeral stream. No water was present in the channel during the site visit, which occurred during the wet season with drier than normal conditions. The flow regime was analyzed at the furthest downstream reach, and the flow characteristics are consistent the entire length, therefore it was determined to be a non-relatively permanent tributary.

Unnamed Tributary (south): ~11,627 linear feet, 320-acre watershed, 4' wide x 6" deep channel with poorly defined bed/bank features. Large rocky substrate in channel. Soil is well drained, gravely silt loam that does not exhibit continuous seasonal flow. Unnamed Tributary (south) is a 1st order ephemeral stream. No water was present in the channel during the site visit, which occurred during the wet season with drier than normal conditions. The flow regime was analyzed at the furthest downstream reach, and the flow characteristics are consistent the entire length, therefore it was determined to be a non-relatively permanent tributary.
